

# Whitewater River Watershed Steering Committee Meeting



## Minutes of November 29, 2016

Whitewater River Watershed

**Attendees:** Heather Wirth, Chris Fox, John Kruse, Jon Seymour, Helen Kremer, Evan Divine, Chuck Goins, and Adam Lehmann

The meeting began at 6:00pm at the Harrison Library in Harrison, OH. After Heather Wirth, Watershed Coordinator, called the meeting to order, attendees were asked to review the previous meeting minutes. With no immediate revisions, members of the committee were asked to let Heather know if they had any additions or corrections that need to be made.

Under new business:

Heather informed the committee the management plan received approval from EPA in August. The plan is available on the watershed website: [www.dearborncountywatersheds.org](http://www.dearborncountywatersheds.org) and hard copies will be developed and available at Franklin, Dearborn, Butler, Hamilton County SWCD offices, local libraries, and local high schools.

The new implementation grant started on November 10, 2016. The grant is funded for 3 years and 3 months, so the end date is February 10, 2020. This grant includes funds for education/outreach and cost-share. Heather reviewed the grant tasks with the steering committee.

The committee spent the rest of the meeting outlining the details of the cost-share program and developing the guidelines. The committee developed the following questions and scores for the ranking sheet.

12. Are you willing to implement the conservation system(s) on your entire farm(s) and rented land?	10

The following are the guidelines the steering committee submitted to IDEM for approval. Applicants in the high priority critical areas, determined in the management plan, will be funded first. If funds are still available halfway through the grant term, applicants in the medium priority critical areas will be eligible. Heather will conduct a field visit and fill out the ranking sheet according to the resource concerns present and what the landowner/operator is willing to improve. A landowner/operator can received up to \$8,000, if funded. There is \$200,000 in the grant for cost-share so at least 25 people can receive funding. All practices will be cost-shared at 70% with the following not to exceed rates.

Funding approval will be determined by the steering committee at least for the first couple rounds. After they review a good number of applications, the steering committee may determine what ranking score range is high and at that time any applicant in that range will be funded automatically. Heather will do the majority of the engineering for the bmps. The NRCS Tech-Team from Greensburg will assist when needed.

A request was made to move steering committee meetings to a day meeting. Attendees who were present were willing to try it and see how it works for everyone else. The next Steering Committee meeting for the Whitewater River Watershed Project is tentatively set for Tuesday, February, 7<sup>th</sup> at 10:15am at the Harrison Public Library. With no further business or concerns, the meeting was adjourned.
