### **State News Updates**

March 28, 2020

- Governor Cuomo held a press conference at 12:00 PM and provided the following information:
  - O Number of deaths is up to 728 from 519 yesterday.
  - o 4,000 ventilators have been sent to New York by the federal government, and they are ready to be used if we get to a point where they are necessary.
  - Still forecast the apex to be 14 to 21 days.
    - Working to get capacity to 140,000 beds.
    - Have enough personal protective equipment for the short-term, but not enough to meet long-term expectations.
      - CDC has put crisis guidelines in place, and the Governor believes this is causing concern among health care professionals.
    - 72,000 volunteers for reserve staff.
  - The Governor believes local hospital systems need to think more holistically, and change their
    orientation so hospitals work more collaboratively to operate and plan as one complete system instead
    of as one single hospital.
    - There may come a point where the State comes in and allocates among the health care system.
      - Some patients downstate may be moved upstate.
  - Asking pharmacies to deliver at no charge.
    - Discussions are happening today.
  - o Department of Health (DOH) is monitoring density and activity in NYC parks.
    - If no compliance, we will close all playgrounds.
  - Hydroxychloroquine and Zithromax:
    - 1,100 tests being administered.
  - Javits Center will open on Monday.
  - o USNS Comfort leaving today to come to New York and should arrive Monday:
    - 1,000 beds.
    - 1,200 medical personnel.
    - 12 operating rooms, a pharmacy, and a laboratory.
  - o President Trump has approved four new sites for temporary emergency medical facilities:
    - Brooklyn: Brooklyn Cruise Terminal.
    - Queens: Aqueduct Racetrack.
    - Staten Island: CUNY Staten Island.
    - Bronx: New York Expo Center.
  - Three other sites have increased capacity by 695, including South Beach Psychiatric Center in Staten Island (260 beds), Westchester Square in the Bronx (200 beds), and the Health Alliance in Ulster County (235 beds).
  - O COVID-only Sites have also been created (600 + beds):
    - 260 beds at the South Beach Psychiatric Center in Staten Island.
    - 200 beds at Westchester Square in the Bronx.
    - 250 beds at SUNY Downstate in Brooklyn.
  - NYS DOH has received FDA approval for an antibody test, to see if individuals have immunity to the virus.
  - o New York State's Presidential Primary will be moved to July 23, the same date as legislative races.
  - o Tax filing deadline for filing Personal and Corporate Income Taxes moved to July 15.
  - Empire State Development Board of Directors approved \$7.5 million in COVID-19 counseling support to 70 non-profit organizations to provide guidance to small businesses.
