**Call meeting to order/roll call**

James Swigart called the meeting to order at 4:33 P.M. Swigart – Chairman, Heather Enzi – Member, Kayla Musselman – Member, were in attendance.

**General Public Comment (FIRST)**

Rob Craven of Nevada Census wanted to give a comment on the Census activities wanted to ask the town board if they'd put in their census and remind anyone who hasn't done it already to do it you can do it online at census.nv.gov. It's estimated we will receive \$20,000 in funding, per person including children that have been counted, for the community.

Olmedo mentioned there are no changes. Total property tax revenue totaling \$797,010. Six governmental fund types totaling \$2,634,119. And one proprietary fund with an estimated total of \$550, 106. There was one change to pages 9 and 10. Change to page 9 for the final budget includes a \$4,000 water charge which increases revenues from \$1,070,010 to \$1,074,010 into the final. Sheriff on the line for PSST tax.

Enzi motioned to approve the final budget. Musselman seconded; motion passed 3-0. Final Budget is approved.

Captain David Boruchowitz reviewed the Sheriff's Department spending plan.

Pool roof was covered with a waterproof shield and the debris has been removed; 2-3 weeks they're hoping to get delivery of the new roofing panels and install. Asking if we want to put our firework show on the next agenda; on the BOCC for next meeting to get our special permit approved. PoolPact gave a disclaimer any Town under their Pool, they will not cover any pandemic bills if a case were to arise at a Town function. Maintenance department plans to fertilize lawns and looking at getting red clay for the softball field. Recreation has been painting, stripped and waxed the floor, working on the kitchen floor, then on installing the dishwasher. Next is paint in the gym. Not sure when we will be able to open the gym. Tonopah is discussing their show at the next board meeting, planning on reaching out to see what they're doing. Hoping the Phase 2 plan will give us an idea on how to go forward.
