- 1. Please fill out the Civil Mediation Intake Form completely and legibly and provide all requested information. The addresses provided for the parties and their counsel should be mailing addresses business address for a business disputes, and home (not work) address for a dispute with a private individual. If the dispute involves rental property, please include the name and mailing address of the owner or management company of that property, unless the local on-site managers have settlement authority.
