Pleasant Faces by Gloria Warner

Boating around Pleasant Lake in the spring is always enticing, to see the changes that have taken place over the winter... new siding, new windows, year round homes standing in place of a cabin torn down. One gentleman who has watched the changes of Pleasant Lake for a lifetime is property owner Kermit Lundeen. Kermit was born and raised in Annandale and has owned property on Pleasant Lake since 1950.

It was a coffee conversation with Kermit and his longtime friend, Dick Anderson, that gave me some insight of Pleasant Lake in the 20's and 30's! Kermit and his family lived at the North end of Excelsior



Avenue, currently (Co Rd 5) which was a gravel road with a sizeable group of Elm trees in the center of the road, near the current boat landing. It was state highway 69 at that time. He told me that people would use this road to get to Fairhaven, before Hwy 55 was developed west of Annandale. The lake was extremely low and the swimming beach was at the East end of the lake. People could pull their cars off the road along what is now State Hwy 24 and plunge in swimming, as there were no homes on that side of the lake. The park property at the North end of Oak (main street) was always there but none of the beach area was developed. There was also a resort on the lake just to the East of Oak, (main) along with four other resorts on Pleasant

Lake in the 1930's. Dick shared that when he first came to the Annandale area with his family they would stay at some of the resorts on Pleasant Lake, Casselius Resort, Heaton's, Dunton's, Shady Lawn,--to name a few). Ferguson's Resort, (the Lundberg property today) was the only thing on the southwest corner of Pleasant Lake.

The two gentlemen chuckled over some of the experiences they shared as young men. Dick told about hurrying to Annandale on Friday nights to go to the outdoor tent shows that would come to town and set up on the shores



of Pleasant, where the Pavilion is today. When Kermit was 14 or 15 years old, he bought a speed boat that had been built from a kit by a previous owner. He bought the ten foot yellow and brown boat for just \$4, and his friend, Floyd Brown, spent \$75 on the 15 hp motor. They used Dick as a windshield since there wasn't one on the boat. They told how, for lack of a boat lift, they just pulled it up on shore and left it there until the next time they went boating. Kermit never worried about it, he always knew the boat would be there.

Kermit and Margaret, built their home on the Southwest side of Pleasant Lake in 1950 and raised their 3 sons in the house he still lives in today. That side of the

Heart of the Lakes Triathlon

On Sunday, July 19th, the 24th Annual Heart of the Lakes Triathlon was held at Annandale City Park. More than 1,100 triathletes participated in the event, many from distant cities, such as Phoenix, Pittsburgh and Portland (Oregon). The conditions were superb, early morning cool temperatures warming up only modestly over the morning, made for *happy triathletes and record breaking times*. The well-seasoned organizing team and the hundreds of eager volunteers once again pulled it off like clockwork, an event that many participants refer to as the “best organized” triathlon in the country! In testimony to its popularity, while most events of this type have not been reaching capacity the past couple of years, our event filled up again this year in just 3 weeks. (*registration is closed at approximately 1000 entrants, teams’ push the participant list over that number.*) All profit from this community event are donated to charitable causes. Recent contributions have gone to the American Cancer Society, Annandale Youth First, Annandale Food Shelf, Annandale Community Education, Camp Friendship and many more.

This year, **on short notice**, we (PLIA) were offered the opportunity to set up a concession stand at this event. We owe a large and sincere “*Thank You*” to Denise



Froehlich for her valiant efforts in organizing this ‘last minute’ venture and for the crew of PLIA members that scrambled with her and helped to

make it a success. The menu consisted of donuts, *Willinghams* “pulled pork” sandwich baskets, vegetable & dip boats and flavored waters. “*In Hot Water*” shared our tent offering Espresso and coffee drinks. Profits from this joint venture will be directed to our newly formed “**Water Quality Improvement Fund**”.

lake was undeveloped at the time. Kermit’s son Vince (and Peni) now live on Pleasant Lake too, not far from the family home. When asked about the changes on the lake during his lifetime, Kermit talked with some sadness about the demise of the resorts and the gradual development of homes on the lakeshore. One of Kermit’s ongoing concerns for the lake is the continual problems with the water level. He feels the control outlet has helped some, but to Kermit this is still an issue to be monitored. Kermit has been a director of the Pleasant Lake Association since its reorganization in 2002.

Listening to two men with a long history of the Annandale and Pleasant Lake area makes us realize the legacy given to all of us who live on this beautiful lake and in this community. We need to take the challenge to share and preserve this lake in whatever ways possible for our children and grandchildren.

A message from your PLIA Chairman...

Brief History of the PLIA

The first meeting to organize was held on July 22nd, 1978 at the Shady Lawn Resort. Harold Kolstad headed the steering committee and presided over the meeting. Many property owners from around the lake were present. When asked as to why the organization was being formed, Harold replied, *"To preserve and maintain good clean water and to protect environment surrounding the lake."*

Elected officers were: Harold Kolstad, President; Joel Carlson, Vice President; Virginia Hall, Secretary and Val Lawler, Treasurer. It was suggested that a board of 16 or so directors be formed to govern the association and that representation be equally represented from all sides of the lake. 16 persons volunteered and all sides of the lake were represented. Membership dues were set at \$10/year. Bylaws and Articles of Incorporation were subsequently drawn up, and were recognized and recorded on the 15th of December, 1978 when **Pleasant Lake Improvement Association, Inc.** was legally certified by the State of Minnesota.

Our Mission

It should be interesting to note that after 31 years, our mission is basically unchanged, *"To preserve and maintain good clean water and to protect environment surrounding the lake."* Our challenge has become greater however. Development in our area has, and will

likely continue to deplete some of the natural filtration of stormwater runoff. Another challenge and on-going concern is the influx of the aggressive varieties of non-native plants that threaten to replace desirable native plants that provide healthy fish habitat. A more recent concern is of the rapid spread of Zebra Mussels to many Minnesota streams and lakes. There is currently no effective control program for this invader once it appears. Public awareness is our only defense.

Thanks for your membership support!

In the recent "flyer" we distributed, we described our efforts (and dilemma) in attempt at controlling the spread of Curly Leaf Pondweed in our lake. We also stressed the need to work together, to make sure we are doing everything we can to maintain the water quality we now enjoy. We have since received renewals from 6 more residents... **Thank you for coming back!** Our current membership now stands at 65% of total properties. In the past couple of weeks, we also did receive a membership contribution from the City of Annandale, for which we are most grateful.

Projects we've been working on...

Our mission *"To preserve and maintain good clean water and to protect environment surrounding the lake."* is a pretty broad description. In addition to **weed monitoring and treatment programs** for the Curly Leaf Pondweed, some of our other activities include an ongoing program of **monitoring lake water quality** in concert with the DNR. This involves regularly scheduled checks and recording of water clarity, through "Secchi Disk" readings, and taking water samplings, which are sent in and documented by the DNR. Past projects include a **storm water runoff study** with the City and Clearwater Watershed District to determine its effect on our water quality. We **monitor the water levels of the lake** and kept a close eye on the Hwy 24 project, in particular with regard to the repair and reinstallation of the outlet control culvert. When MNDOT decided to install new culverts under the highway which would allow direct runoff into our lake and cause washouts on the beach of our residents, we voiced our objection, engaged our Representative and ultimately got it corrected. **Repair and upkeep of Loon nesting structure** as

needed to keep our summer residents happy here. **Arranged to have signage put in place**, when we found that there were no signs at our boat landings to remind boaters to check their boats for weeds. For the past few years, members of our board have agreed to provide **volunteer service as Water Patrol** to help DNR authorities in maintaining safety on our lake. As your representatives, every member of this board is committed to **"the mission"**.



Lake Neighborhoods...

Many "Thanks" to Jim Peterson, Gloria Warner and Steve Bruggeman for their work in creating a detailed map of our lake properties with an accompanying list of current residents. We plan to use this map as part of our Pleasant Lake Directory, which is presently under construction. Ideally, it would be nice to see board representatives from all around the lake. Two of our neighborhoods, the **Town Shore** and the **West End** are well represented. The **East Side** and North shore not as much. Since the North shore consists of twice as many homes as the other 3 neighborhoods, we propose counting it as two separate neighborhoods, **Park North** and **North West**. This would give us 5 similarly sized neighborhoods of 25-30 properties each. Below is a copy of the map with the proposed neighborhoods.
