Stantec Consulting Ltd.'s request for approval to construct a natural gas pipeline within the RM (to be installed in a new 18m right of way from SW 13 08 06 W2 to SE 35 04 04 W2) shall be deferred until next meeting. The Acting Administrator shall call Stantec Consulting Ltd in regards to the land locations.

COUNCIL REPORTS

A discussion arose regarding road construction on Township Road #40. It was decided that this may be a good project to have shovel ready for grants in 2010.

The Acting Administrator informed council that a list has been started for those who request gravel. This list shall be provided to the foreman and he will decide when each person shall receive gravel.

A question was raised by a rate payer in regards to dust control. It was advised that the RM has a policy which states that the RM will provide dust control at the rate payer's expense. It will only be done if there is enough to make it worth doing.

Reed Gibson noted that the air conditioner is not working in the CAT Grader. He also noted that the Foreman needs to be contacted in regards to grading Red Barn Road. He informed council that a cat walk off the back of the one ton truck is being built and that an air compressor is needed.

Reed Gibson also discussed the need to tender tree removal along the roads.

It was decided that Jeff Humphries shall call Carlyle Contracting Services Ltd. Regarding beginning gravelling.

It was mentioned that there is water running across the McCally's Crossing. Marlowe Brown will call Water Ways.

SMR SM

Extraction fees of \$0.07 on gravel for outside the RM were discussed. The Ministry of Highways inquired about using the RM's gravel from the Cobham Pit, for highway 361. It was mentioned that a cost of \$0.25 may be added to the costs. The Reeve shall contact Highways to find out an exact amount. This item will be deferred to the next meeting.

Scott Hewitt mentioned sending a letter to SaskWater lease holders regarding fire insurance. It was suggested that Bonnie Thompson be contacted to clarify what type of insurance is needed.

Marlowe Brown suggested that someone from the Fire Department be appointed "Fire Inspector".

The purchasing of a fire truck was discussed. It was suggested that the fire department specify exactly what is needed so that an appropriate quote can be obtained. It was also suggested that the cost of the fire truck be split over two years' budgets.

The purchasing of a grader was discussed. It was noted that the CAT has less hours than the John Deer. The Reeve shall talk to the Forman about using the CAT more. It was also mentioned that council consider upgrading the third grader as opposed to purchasing new.
