Olmedo reviewed the correspondence.

Olmedo reviewed the correspondence list. DTAX had a meeting this morning with the county. Eason Insurance merged with A&H Insurance out of Reno. A&H will have a better chance of working with the cities helping with payroll and Eason will still be doing our vehicles. The water department was aware of a major leak up in Old Town. We noticed because the operator noted our tanks were draining faster than they should be. The leak surfaced and was near the cemetery, and then Tuesday evening a residence reported a leak and they were able to get that fixed Wednesday morning. Working towards our motor grader, Cashman came down and serviced and brought new batteries and we have the tires getting put on soon and then one of our Volunteer Firemen will come show us how to use it. In conjunction with RMGC we will have two of our guys crane certified so they will be 4 days studying, training, and working one on one with the crane company and we're hoping that they will be able to pass. Smoky Valley Tire was able to help find the issue for both sanding units. Fireworks proposal, we've received two, Lantis and Fireworks West. Fireworks West is who we have used for the last couple years.

Review and approve invoices for the Town of Round Mountain

Enzi motioned to approve. Spivey, Jr. seconded; motion passed 3-0. Invoice were approved.

Budget Workshop for fiscal year 2020 – 2021

Olmedo reviewed salaries with no cost of living increase and benefits for Administration, Fire, Recreation, Pool, Buildings & Ground, and Round Mountain Public Utilities, the enterprise fund.

Admin: Salary no cola - \$133,906, Salaries - \$302,906.00, Retirement - \$39,787.61, Workers Comp - \$18,799.99, Insurance - \$27,922.58, Medicare - \$2,014.14, Social Security - \$178.56, Total salaries & benefits - \$391,608.87.

Fire: Salary no cola - \$12,000, Salaries - \$12,000, Workers comp - \$13,015.14, Medicare - \$174.00, Total salaries & benefits - \$25,189.14.

Recreation: salary no cola - \$72,446.40, salaries - \$72,446.40, retirement - \$21,190.57, workers comp - \$3,702.86, insurance - \$22,338.06, Medicare - \$1,050.47, total salaries & benefits - \$120,728.36.

Swimming Pool: salary no cola - \$39,360.00, salaries - \$39,360.00, workers comp - \$2,197.34, Medicare - \$570.72, social security - \$2,440.32, total salaries & benefits - \$44,568.38.

Buildings & grounds: salary no cola - \$111,628.80, salaries - \$111,628.80, retirement - \$32,651.42, workers comp - \$4,853.79, insurance - \$83,767.73, Medicare - \$1,618.62, total salaries & benefits - \$184,259.72.

Total for all departments: \$851,119.40, with \$0.50 COLA increase goes ups to \$868,121.58.

Spivey motioned to approve \$0.50 COLA increase. Enzi seconded; motion passes 3-0. COLA of \$0.50 is approved.

Neil Jensen gave an update regarding the current housing situation. Round Mountain Gold Corporation has funding and looking to purchase housing units for employees needing a room only. This will free up houses for those needing a home for their families.
