## MINUTES FOR THE AHAN BOARD OF DIRECTORS MEETING, JULY 2, 2013

DeAnne Allen, Julie Koch, Sigourney Inman, Julie DeBoer, Danielle Malone, Sheri Savig and Jim Carr were in attendance. Randy Johnson and Shellee Kotera were absent.

**MINUTES:** Secretary Julie Koch presented the minutes of the April 9, 2013, and June 4, 2013, meetings. Julie DeBoer moved to approve them as presented and Sheri Savig seconded. Motion passed.

**TREASURER'S REPORT:** Julie D. presented the treasurer's report. As of July 2, AHAN had \$41,149.39 cash on hand, with total assets and liabilities of \$41,914.39. Julie K. moved to approve the treasurer's report and Jim Carr seconded. Motion passed.

**HIGH POINT:** No report.

**PUBLICATIONS:** Nothing new to report.

**MEMBERSHIP:** Julie K. reported that as of July 2, AHAN had 75 adult members, 5 life and 21 youth. Sheri asked Julie to send her a list of the current youth members so Sheri could let them know about the royalty contest.

**SHOWS:** GPAC -- The net income for the show was \$150.46. August show – Kandice Rasmussen has agreed to help. DeAnne has received the judges' contracts back, and needs to reserve hotel rooms for them. We still need a ring steward and paddock manager. There will be games held after Saturday's classes.

**ROYALTY:** Sheri reported that the riding portion of the contest would be held after Saturday morning's classes at the August show. She also asked if AHAN was interested in having a booth at a school carnival at her daughter's school. The board wanted more information. Julie K. said she would put a royalty contest application in the Hoofbeats.

**NEW BUSINESS:** Jim and Danielle said they would not run for the board again.

**NEXT MEETING:** Sept. 10, 7:30 p.m.

Julie K. moved to adjourn and Julie D. seconded. Motion passed and meeting was adjourned at 8:35 p.m.

# Arabian Horse Association of Nebraska membership application



The Arabian Horse Association of Nebraska (AHAN) is a nonprofit organization dedicated to the promotion of the Arabian horse. Membership is open to all individuals and families with an interest in Arabians, whether or not they own an Arabian.

## VOTING MEMBERSHIP

**Adult:** The first adult membership of any household (defined as the same address) is \$40. Each additional adult membership from the same household is \$30. All such members will have the rights and privileges pertaining to voting members, except that only one newsletter will be sent to each household. Families should bear in mind that only the person who joins will be eligible to participate in AHAN and AHA (Arabian Horse Association) activities. Voting membership includes membership in AHA, one vote, directory listing, monthly newsletter and eligibility for AHAN programs.

## NONVOTING MEMBERSHIPS

**Youth:** For youth under the age of 18 as of Dec. 1. Includes a directory listing, monthly newsletter, AHA youth membership and eligibility for all AHAN and JAHAN programs.

**Associate:** For those who are not an AHA affiliate through AHAN. They have no voting rights and are not eligible to hold office or be a delegate. Associate members are eligible for all AHAN programs, including High Point.

**Membership is 12 months from date of application.**

**Dues are due before the end of the last day of the month in which membership expires.**
