INDEPENDENT CONTRACTOR AGREEMENT

Article 1. Performance of Work

(c) Adaptive Solutions Multi Services's Principal Coordinator for this Agreement will be _______at its Department of _______. All services provided for herein shall be performed to the approval of such Principal Coordinator.

Article 2. Term and Termination

(b) Adaptive Solutions Multi Services may immediately terminate this Agreement based upon a breach of this Agreement by

Contractor, by delivery of written notice thereof to Contractor at Contractor's address as noted above.

Either party may also terminate this Agreement without cause on 30 days written notice, by notice delivered to the address of the parties as noted above; in such a case, Adaptive Solutions Multi Services will proportionately reimburse Contractor for all work expended up until the time of termination.

Article 3. Payment

(a) Rate

(b) This Agreement may not be assigned in whole or in part without the prior consent of Adaptive Solutions Multi Services.

(c) All Contractors performing services on Adaptive Solutions Multi Services premises shall provide and maintain insurance to indemnify Adaptive Solutions Multi Services as provided in Article 11 of Adaptive Solutions Multi Services's General Terms and Conditions. Contractor shall, at Contractor's sole cost and expense, defend any such litigation brought against Adaptive Solutions Multi Services. Contractor's obligation under this paragraph shall survive Adaptive Solutions Multi Services's acceptance of, and payment for, the goods, products, systems, services and/or work.

(e) This Agreement shall be governed by the laws of the State of New York without regard to its rules concerning conflicts of laws and the parties hereto consent to the jurisdiction of either New York State

Courts or US District Court for the Northern District of New York for any disputes arising hereunder, with venue to be established in either New York or Kings County, New York.

(f) Contractor warrants and represents that he or she has the full right to enter into and execute this

Agreement and to undertake the obligations set forth herein.

(g) This document contains the entire Agreement of the parties, and may not be altered or amended except by a subsequent document signed by both parties.

(h) Adaptive Solutions Multi Services's General Terms and Conditions, is incorporated herein by reference, except to the extent expressly amended, superseded or contradicted by an express provision contained in this Independent Contractor Agreement.
