### Call meeting to order/roll call

Olmedo reviewed correspondence. Update on tabled item nine, we're still gathering all the information we can find from when the fuel tax resolution went into place so it can be reviewed. RMPU credit card transaction online system still seems to have a glitch that they cannot iron out. They have to get the software talking to each other and then they will do one more soft launch to make sure it works like we want. Sent proposal to Fireworks West for fireworks. Renewed certificates for operators of record for July 4<sup>th</sup>, there were three volunteer firemen. Reached out to Lumos & Associates regarding Nitrogen Reduction Plan, Public Utilities department is tasked with gathering information as far as oxygen reads, a diary of what happens at the sewer plant. Lumos plans to tour the sewer plant and bring the information to a board meeting after.

There are some Capital Outlay projects budgeted this year for recreation and pool; replacing the gym floor with \$80,000 budgeted and replacing the chemical shed at the pool with \$20,000 budgeted. The board was asked if they would like to still see budget approved capital outlay projects on the agenda or if they would just like to know what and when we're planning to spend, and receive updates. The board agreed updates would be the preferred method.

Spivey mentioned that there have been a few people asked him about using the pool year-round and if there were any plans to insulate it.

# Round Mountain Town Board Meeting 3/12/19

Olmedo explains that last board meeting she had asked for Board input regarding those types of capital outlay projects. A project Recreation is working on is a little league field, gathering costs and information. Once Rec gets those figures lined out, it will be something to request in the budget as capital outlay.

Spivey motioned to approve the invoices. Musselman seconded; motion passed 3-0.
