James Swigart called meeting to order at 4:31 P.M. Swigart – Chair, Craig Barber – Vice Chair, and Heather Enzi – Member were in attendance.

Approval of the May 12, 2020 agenda

Barber motioned to approve. Enzi seconded; motion passed 3-0. May 12, 2020 agenda is approved.

Approval of the April 28, 2020 meeting minutes

<u>Discussion and decision to accept Daniel C. McArthur, LTD fee of \$13,904, to audit Town of Round Mountain's financial statement for year ending June 30, 2020</u>

<u>Discussion, deliberation, and possible decision to approve the purchase of Vacuum Excavator using Round</u> <u>Mountain Public Utilities Capital Outlay Fund</u>

Olmedo explains that this piece of machinery will aid our operators in quickly being able to fix a major leak as it will quickly get all the water out. A year ago, it took them an entire business day and into the night just to get the water out to get to the source of the problem to fix it. A used one from Vermeer comes in at \$50,262.00. And then from the same company a new one would be \$52,988.44. The Ditch Witch of Arizona quote is for \$54,934.26.

Tonopah utilizes the Vermeer and sees a significant reduction in time in being able to repair leaks. Recommend going with the Vermeer Southwest new one that way we could share parts with Tonopah Public Utilities if need be.

Enzi motioned to approve. Barber seconded; motion passed 3-0. New Vermeer Southwest quote is approved.

<u>Discussion, deliberation, and possible decision to approve, amend and approve draft resolution to return fuel tax monies to Nye County held in Town of Round Mountain's General Fund</u>

Barber explains that all we want is the roads to be taken care of by the County. Would be beneficial if Pearl, Rebecca, and I went and laid out all of our information. Continuing resolution that we give 75% of the funds back and keep 25% of it and have the County take care of the roads. Pearl Olmedo explains that to do that we would have to get on their agenda and mention that Craig is representing the Board as a whole at a B.O.C.C. meeting or we could request to have an informal meeting. Barber explains it would be best to go in with handouts and would like to get a total amount of what is in the account.
