

#### News from Around the Shores St. Augustine Shores Service Corporation April 9, 2015 Board of Directories Summary

St. Augustine Shores Service Corporation's Board of Directors held their April 9, 2015 regular meeting at 7:00 p.m. and conducted the following business

1. Approval of the Minutes – March 12. 2015 was made by unanimous motion.

Treasurers Report – Approved and accepted for audit with Reserve Fund

Expenditures explanations.

The ACC Committee had 1 meeting in the month of March where there was

discussion about window replacement not needing to be permitted by the ACC.

The AČC Committee also approved 9 applications:

5 fences

1 Florida room

1 new house

1 screen room

1 shed

Total approved YTD 154

The General Manager discussed the Pool Marcite Project and explained that the pool chemical balancing for 200,000 gallons of new water is progressing for pool opening.

He also explained the progress on the Pool Bathhouse Project is moving slower than planned, but stated that the pool is scheduled to open between April 15 and the end of the month.

5. The Board was informed that the Commission voted against Deltona's bid for a major modification to the PUD changing front setbacks on 16 lots in Unit 7 from 25 feet to 20 feet. Without this change, Wetland buffer question would cause development issues. The General Manager provided Deltona's representative attending the meeting with contact information for St. Johns River Water Management.

6. The General Manager provided the Board with a copy of the revised Baker Landscaping Contract for approval. An e-mail from Internal Audit Committee Chair Lance Conner was presented in support of the revised contract. Following Board discussion the Board approved the Baker Landscaping Contract for 3 years.

7. The General Manager reported that the Election Committee has met and the audited return envelope processing has commenced. 475 proxies received to date. 513 needed to establish a quorum. Future processing set for April 27 and April 30. 8. The General Manager reported that the Pier Staining and Playground Mulching budgeted projects have been completed.

9. The General Manager provided a Deed Violation packet to each Board member that included the initial report of the violations, a printed copy of the entry into the Pride system, a printed copy of the follow up detail from the County Code Enforcement Department and a follow up report on violations reported in the prior month which explained the process.

10. The Directors comments:

We should stop printing out the Deed Restriction Report for the meetings.

What is the status of the park stop Fakahatchee grass replacement project? The Board needs support and plans to meet with Commissioner McClure about bus kiosk grant funding.


#### Temple Bet Yam to Host Wine & Cheese Reception for Prospective Members



#### Wild Flower Meadow Group





# **St. Johns County Sheriff's Corner**

#### Proms, Parties & Alcohol

We are fortunate in St. Johns County to have a wonderful population of young people. You often read of their many accomplishments in this publication. As we approach prom season and graduation I urge parents and all citizens to join with the law enforcement community to do everything we can to help keep our celebrating students safe.

One major concern is underage alcohol use and abuse. In recent years we have seen some promising young people from our high schools killed in crashes where alcohol consumed at parties was a contributing factor. The 2014 Florida Youth Substance Abuse survey of St. Johns County found 57.4 percent of high school students had used alcohol in their lifetime, this is way down from over 75% of high school students who had used alcohol in their life eleven years ago. More than 27.9 percent had consumed alcohol in the past month of the survey and 9.5% reported binge drinking in the past 30 days. (five or more drinks for males and 4 or more drinks for females for the sole purpose of getting drunk). The numbers for our Middle School students in the survey is as follows: 21.9% have used alcohol in their lifetime, which is also down from the 2004 survey that revealed over 40% had used alcohol in their lifetime. More than 7.5% had consumed alcohol in the past month of the survey and 2.3% reported binge drinking in the prior 30 days of the According to the National Highway Traffic Safety Administration the leading cause of death for 15 to 20 year olds is a car crash and 23 percent of teen drivers in fatal crashes had a blood alcohol content in excess of .08, the legal limit for drunk driving

Another federal study found that of the nearly 70 percent of high school students who have consumed alcohol in the past 30 days 49 percent purchased it illegally, 30 percent got it from an unrelated person of drinking age and 21 percent were provided alcohol by their parents or another adult family member. In an effort to reduce these alarming numbers we continue to partner with the St. Johns Country School Board and the PACT Coalition (Prevent-Act-Change-Together) to create educational

awareness of the dangers of alcohol for our young people.

We all should be concerned about the potential risky behavior of young people associated with proms, graduation parties and school year end celebrations. Here are 7 suggestions for parents to help ensure that their sons and daughters arrive home safely after attending such events.

1. Have a very specific conversation with your teen about alcohol consumption, driving under the influence and resisting peer pressure that often leads to poor judgment before, during and after proms and parties.

2. Find out who will be driving, their address and phone number and a list of names and phone numbers for each teen passenger.

3. Get a planned itinerary and stress that no changes to it be made without approval.

4. Talk with your teen specifically about how he or she will handle difficult situations such as being offered alcohol or drugs or turning down a ride with an intoxicated driver.

5. Make sure your teen has a cell phone or some other means of contacting you throughout the entire evening and perhaps even set up specific check in times.

6. Program the number of a reliable cab company into their cell phone. They may more comfortable calling for a cab in front of their peers than calling home for a ride.

7. Lastly, monitor your student's social media sites. Their friends or contacts, evening plans, etc.

It is my hope that our high school juniors and seniors in St. Johns Country will use good judgment and safely enjoy their proms and graduation parties. We at the sheriff's office will do all we can to make sure the roadways they travel are safe.

#### Gamer's Thumb

I've written about Wii-itis, which is another name and cause for Tennis elbow or lateral epicondylitis. There is also a Gamer's Thumb, otherwise known as de Quervain's Tenosynovitis. It is a real problem and I'm not making this stuff up. Gamer's thumb or de Quervain's Tenosynovitis can be very painful and debilitating. For those who use their hands for work it may hinder such tasks.

De Quervain's Tenosynovitis occurs when a sheath around the thumb tendon's gets inflamed. Two particular tendons that move the thumb are surrounded by what is called a synovial sheath. When the sheath is abnormally stressed or rubbed by the tendons, it gets inflamed and causes pain. It's called Gamer's Thumb because it most commonly effects gamers, those who play video games, Xbox, Play Station but can also be a problem for those who text a lot or even some jobs where the hands are used a lot. For that reason it is categorized as a repetitive stress injury.

De Quarvain's Tenosynovitis is often diagnosed with the Finkelstein test. The test is performed by folding the thumb down into the palm. While maintaining that position, the grasped thumb and hand are bent in the direction of the pinky, as if one were casting a fishing pole. If a sharp pain is produced over the thumb, wrist or arm, a diagnosis may be made. Other tests are done to confirm and/or rule out similar problems. The tendons are also very tender with palpation.

Conservative treatment can be quite easy and successful. The first thing to do,

and sometimes the most challenging, is to first remove the stress from the tissues. This is something easier said than done for habitual texters or gamers. If necessary, the thumb can be taped in a way to protect the tissue or placed in a splint, which is more restrictive. Treatment may also include soft tissue manipulation or joint manipulation if they too are restrictive. Eventually stretching is performed followed by strengthening.

Reversing the effects of Gamer's Thumb does not take long, provided the stresses through the thumb are reduced. It's just a matter of controlling the stresses, allowing the tissues to heal and then slowly working on proper function. In chronic or reoccurring cases, adaptive equipment may be prescribed such as built up grips or larger electronic devices.






