State News Updates

May 1, 2020

- **Governor Cuomo held a press conference at 11:30 AM and announced the following:**
 - Total hospitalizations under 11,000 as of April 30/total deaths increased by 289 on April 30.
 - Must target efforts to reduce new cases, as there were almost 1,000 new hospitalizations for COVID-19 on April 30.

- Need to find out more information on cases such as address, how they commute, where they work, where they live, are they at nursing home, demographics.
- **K-12 schools and college facilities will remain closed for the rest of the academic year, and will continue to provide distance learning for the remainder of the academic year.**
 - **Decision on summer school programming will be announced end of May.**
 - Meal programs and child care services for essential employees will continue.
- Schools have high density and transportation issues, and there is great risk of spread unless protective measures are fully in place.
 - 700 public school districts with 4,800 schools and 2.59 million students.
 - 1,800 private schools with 400,000 students.
 - 89 SUNY/CUNY campuses with 700,000 students.
 - Over 100 private colleges with 500,000 students.
 - Total K-12 and College: 4.2 million students.
- State will approve plans to reopen schools and colleges. Plans should consider:
 - How can schools monitor spread of COVID-19?
 - How do we instill parent confidence and reinforce student safety?
 - When and how will extra-curricular activities reopen?
 - Do protocols for special student populations change?
 - On college campuses, how will housing, meals, and gatherings work?
 - What steps need to be taken to ensure student mental health?
 - How can colleges work together to share services and offer opportunities across public/private systems?
 - Would any alternative academic calendars work?

- [Governor Cuomo issued Executive Order 202.26 to allow for voting for school districts, local elections, and provides changes to the June 23 election process. Highlights include:](#)
 - [School Districts and Libraries Elections and Reporting Dates](#)
 - School budget and school board votes for every school district, outside the Big 5 school districts, will be held on June 9.
 - Notices for the meeting will be sent out to the voters 28 days before the election.
 - The notice will be in the form of a postcard highlighting the date of the election, date of the budget hearing, definition of a qualified voter, and an absentee ballot.
 - Votes will be conducted via absentee ballot with a postage paid return envelope sent to each qualified voter.
 - Any library board election will be conducted via absentee ballots mailed to all eligible voters with a postage paid return envelope.
 - School district annual report cards are to be submitted to the State Education Department no later than 18 days prior to the budget vote and will be compiled together no later than June 2.
 - Signature requirements to be on the ballot for school board elections and library board elections are waived, with all other requirements to be on the ballot still necessary.

 - Any village election previously scheduled to be held in March, April, May, or June will be held on September 15.
 - For any village election scheduled to be held on September 15 as directed by this Executive Order, all party nominations shall be made by party caucus.
 - All independent nominations for a village election previously scheduled prior to September 2020, now to be held on September 15, shall be postponed until such time as NY on Pause is suspended.
 - Village officials elected at a rescheduled election held on September 15, shall assume office as soon as the statement of canvass is filed with the village and such terms shall end as if they had been elected at the time of the originally scheduled election.
 - [June 23 Elections](#)
 - Any absentee ballot sent to a voter for a primary or special election to be held on June 23 shall be provided with a postage paid return envelope.
 - Board of Elections will maintain a voting system that is accessible for voters wishing to mark their absentee ballot privately and independently.
 - It shall be permitted that any Justice of the Supreme Court appointed to hear election matters on election day to hear and determine such matters telephonically or by video conference.
 - Inspectors of the board shall not attend and/or visit facilities described in Section 8-407 of the Election Law (Nursing Homes and Care Facilities) and shall instead mail or deliver absentee ballots to voters residing in such facilities.
