RIVENHALL PARISH COUNCIL MINUTES OF THE COUNCIL MEETING HELD 7 JUNE 2016

1278. To receive any apologies for absence.

An apology was received from BDC Cllr. Bowers

1279. Disclosure of Pecuniary Interests relating to matters on this Agenda.

Cllr. Abbott declared non-pecuniary interests in all matters relating to ECC and the BDLHP.

1280. To approve and sign the Minutes of the meeting held on 3 May 2016.

The minutes were unanimously approved and then signed by the Chairman.

1281. Public Forum for 10 minutes.

The following matters were brought to the attention of members:

- Bridleway/Footpath via Hoo Hall Clerk will contact ECC.
- As ECC has currently rejected the restriction of through traffic along Rectory Lane (a Protected and Quiet Lane) the Clerk will seek guidance for further RPC action from CPRE and the Chairman will raise the issue again at the next BDLHP meeting on 7 July 2016.
- M/cycles are still being ridden along the John Ray Walk.
- Overhanging branches and foliage along the Oak Road footway require trimming. The Clerk will arrange this with the maintenance contractor.
- Roadside verge cutting has recently commenced.
- Excavations have commenced for the Rivenhall Oaks Golf Centre lake.
- The Clerk will check the details included in the diversion notice for Footpath 60.

1282. Matters for Discussion.

i. Tarecroft Wood.

ECC will be undertaking certain woodland conservation survey work this spring and summer in support of the woodland conservation management they propose to undertake in the autumn/winter of 2017/18 as part of a Countryside Stewardship Agreement that encompasses the County Council woodland estate - circa 300 hectares of ancient woodland across 25 sites

ii. <u>Tusser Close garages and fly tipping in the ditch at the rear.</u>
The Chairman is meeting a Greenfields representative on 10 June to

iii. <u>Parking on the Village Green.</u>

BDC have ceased erecting "No Parking" signs for village greens as experience indicates that drivers take little or no notice of the signs. "Polite" notices have worked in some parishes and BDC agreed to supply for the Clerk to display on offending vehicles - these notices are still awaited.

- iv. Network Rail possible crossing closure on Footpaths 45/43.

 Network Rail are holding a consultation event on Thursday 16 June in Witham Public Hall, from 14.00 to 19.00 hours, re the possible closure of the main line level crossing at Footpaths 45/43. A pre-meeting for local Councillors or representatives commences at 13.00 hours.
- v. <u>ECC consultation on bus fare increase on council buses.</u>
 A consultation is being launched on Monday 9 June into changes to bus fares on services provided by Essex County Council. ECC propose an increase of about 5% for the next three years about 10p per ticket. The Witham to Tollesbury routes 91 Monday/Saturday and 95 Sunday via Rivenhall End appear to be the only routes affecting this parish.
- iv. <u>ECC Highways maintenance.</u>
- ECC confirm that the broken sign on Rickstones Road should be replaced within the next six weeks.
- Defunct street lights along Oak Road will be notified to ECC.
- The Church Road Zebra beacon has been repaired.
- The maintenance contractor will be requested to trim back the overgrown shrubs at the junction of Oak Road and Henry Dixon Road.
- Part of the A12 cycle/footway still remains to be completed. General maintenance.

Proposed by Cllr. Prime, seconded by Cllr. Anderson and agreed with 1 abstention that the sum of £40.00 each be allocated for Rivenhall End and Rivenhall Village summer planting. The Chairman agreed to do the planting in Rivenhall Village.
