**Event Sponsor:** Will provide 1 table, 1-2 chairs, waste bin and nominal basic electricity in the venue.

The venue is a non-smoking facility. Smoking is only allowed on the outside grounds.

Set Up: 6:30AM – 8:30AM (Set-up should be complete no later than 8:30AM).

To gain entrance for set up, come to the venue. Each vendor has a designated location.

Vendors are asked to display within your allocated space(s).

All loading and unloading is to be done through the appropriate entrance only. Please do not block the drive way for any reason. Once unloaded please immediately move your vehicle

and park in the designated area. This will allow all vendors prompt access.

Each vendor is responsible for table covers, all equipment, power extension cords, decorations, signage and supplies for his/her exhibit. Vendor is responsible for keeping their

space organized and clean. Please place all boxes under your table.

**Breakdown**: Breakdown should begin at 3:00PM or once you have finished with your clients after the

event. All vendor items must be removed from the premises on the day of the event. Empty

All trash must be discarded and return table and chairs to appropriate places.

**Food/Drink:** Outside food or drink is not allowed during the event. Food and drink is allowed if you are

an approved food/beverage vendor or sponsor.

Food Vendor: Food vendor must provide all supplies such as warming and serving utensils ex. Plates,
