## **CONTRACT**



- 1. Minneapolis Ballet School is an equal opportunity fine arts establishment.
- 2. Acceptance to study, placement of student in appropriate class levels and performance casting is at the discretion of the director. Placement is subject to change at any time based on student's attendance or lack thereof, effort, ability, and attitude/level of enthusiasm.
- 3. Tuition is payable prior to participation. Students with unpaid tuition may not be allowed to participate. Tuition is due by the 15<sup>th</sup> of each month after which there is a \$25 late fee added with no exception. Tuition is not refundable.
- 4. Photo and video of MBS students, classes, activities, and performances are property of MBS and MBD and I consent that it may be used for promotional purposes.
- 5. Students are to arrive for class timely, in designated attire with hair up, and no gum.
- 6. Students who demonstrate disrespect towards instructors, directors, authoritative figures, volunteers, or other students or cause disruption will be excused from class and/or productions and may be terminated from MBS.
- 7. No alcohol, drugs, or weapons are allowed in MBS studios.
- 8. Students have the option to make up missed lessons within 30 days of the absence.
- 9. Participation fees in addition to tuition may be charged for rehearsal time, costumes, and tickets in conjunction with performance opportunities. These fees are non-refundable.
- 10. The director reserves the right to terminate any student at any time without notice.
- 11. I understand that a certain amount of risk is involved in participation in the learning of dance and agree not to hold MBS liable should injury occur.
