Call meeting to order/roll call

Swigart called the meeting to order at approximately 4:30 P.M. Swigart – Chair, Craig Barber – Vice Chair, and Robert Spivey, Jr. – Clerk were in attendance.

Pledge of Allegiance

The pledge of allegiance was recited.

General Public Comment (FIRST)

There was none.

Approval of the March 10, 2020 agenda

Barber motioned to approve. Spivey, Jr. seconded; motion passed 3-0. March 10, 2020 agenda was approved.

Approval of the February 25, 2020 meeting minutes

Barber motioned to approve. Spivey, Jr. seconded; motion passed 3-0. February 25, 2020 meeting minutes approved.

<u>Discussion and decision to designate Daniel C. McArthur as the Town of Round Mountain's auditor for</u> Fiscal Year 2019 – 2020

Barber motioned to approve. Spivey, Jr. seconded; motion passed 3-0. Daniel C. McArthur approved as auditor for fiscal year 2019 – 2020.

<u>Discussion</u>, <u>deliberation</u>, <u>and possible decision to approve</u>, <u>amend and approve letter to Nye County</u> <u>Board of County Commissioners regarding Hadley Subdivision Roads</u> Barber recapped what changes were requested at the previous meeting. Olmedo explained the copies given with suggestions from everyone.

Spivey, Jr. motioned to approve. Barber seconded; motion passed 3-0. Letter to Nye County Board of County Commissioners regarding Hadley Subdivision Roads was approved.

<u>Discussion</u>, <u>deliberation</u>, <u>and possible decision to approve</u>, <u>amend and approve draft resolution to return</u> fuel tax monies to Nye County held in Town of Round Mountain's General Fund

Barber reviewed the 1991 and 1992 resolutions regarding the dedication and acceptance of the roads. Reviewed the 1995 resolution creating an account line item within the Town's general fund to put the road tax money we had been and were already receiving in our general fund, so as to be compliant with NRS per auditor's recommendation. Stated he was still doing research on the 1.75 tax and what the intentions of the legislators' was for that tax when it was created. Olmedo mentioned that Nye County would be having a public hearing regarding road planning Tuesday, March 17, 2020 and office staff would arrange to attend.

Will be installing two t-ball fields. Opening day for little league is April 4th, water will be turned on last week of March.

Review and approve invoices for the Town of Round Mountain

Spivey, Jr. motioned to approve. Barber seconded the motion; motion passed 3-0. Invoices are approved.

Budget workshop for fiscal year 2020 - 2021

Olmedo reviewed four departments – buildings & grounds, fire, pool and recreation.

Buildings & Grounds: Salaries & wages -- \$114,869; Employee benefits - \$73,766; Service & Supplies - \$117,600; Capital outlay - \$500,000; Total - \$806,235. Fire Department: Salaries & wages - \$12,000; Employee benefits - \$16,860; Services & supplies - \$129,100; Capital Outlay - \$41,510; Total - 199,470. Swimming Pool: Salaries & wages - \$39,360; Employee benefits - \$5,208; Services & supplies - \$43,300; Capital outlay -

\$104,000; Total - \$191,868. Parks & Recreation: Salaries & wages - \$74,606; Employee benefits - \$49,052; Services & supplies - \$104,200; Capital outlay - \$177,000; Total - \$404,859

Barber motioned to approve. Spivey seconded; motion passed 3-0. Budget workshop is approved.

General Public Comment (SECOND)

Emily Hendrickson spoke on behalf of the Hospital District to remind us that Central Nevada Regional Care is now open in Tonopah in the clinic space and is accepting new patients. They have a doctor on site. They do diagnostic tests, labs, and Urgent Care. Open Monday through Friday 8am to 8pm and open on Saturday's and Sunday's 8am to 4pm. There is also a 24 hours on call line.
