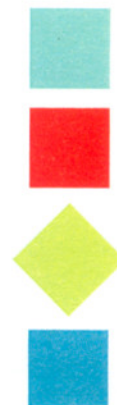

Dear the Honourable Attorney General,

We are writing to express our grave concern over the impunity of the three criminals Mahamoud Doualeh Hersi, Mohamed Ismael Hersi and Abdi Ali Haid (please read the criminal complaint sent to President Dahir Riyaale on december 2008).

The corrupted officers (Mahamoud Doualeh Hersi, Mohamed Ismael Hersi and Abdi Ali Haid) didn't return the stolen items to the Canadian family victimized abroad, professor Houssein Ahmed Abdi and they live with impunity.

We condemned the crime and the responsibility of the defendants (Mahamoud Doualeh Hersi, Mahamed Ismael Hersi and Abdi Ali Haid) who have access to large sums of money obtained through their various criminal enterprises.

Criminal Mahamoud Doualeh Hersi went to Saudi Arabia with the ransoms money in 2008.

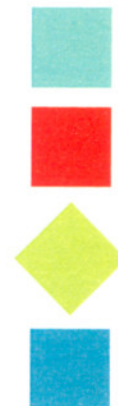

We already requested the restitution of the stolen items (value : US\$18 000) to the canadian family victimized abroad and the incarceration of the defendants on the ground of the criminal code.

Kidnapping, torture, extortion, ransoms, assaults and other violent crimes with the support of the criminal Mohamoud Doualeh Hersi should not tolerate in Somaliland province.

Furthermore, the warrant of arrest issued by Hargeisa Court (Judge Cheick Issa Yussuf) is based on sufficient evidence. However, bandit Mahamed Ismael Hersi (red guy) broke these procedural safeguards for financial reasons and he destroyed the life of the canadian taxpayer professor Houssein Ahmed Abdi with absolute, unrelenting prejudice.

We believe that it is a matter of a **denial of justice** and the defendants (Mahamoud Doualeh Hersi, Mahamed Ismael Hersi, Abdi Ali Haid) are guilty for criminal activities within Hargeisa police (home invasion-armed robbery, kidnapping, torture, extortion and ransoms).

Usually wanted criminals who committed murder or armed robbery are safe in Somalia.

As the Crime committed in Hargeisa, RCMP Canada can get involved.

Three bandits (Mahamoud Doualeh Hersi, Mahamed Ismael Hersi and Abdi Ali Haid) were found guilty for the attempted murder, kidnapping-armed robbery in Hargeisa against the victim Canadian family Professor Houssein Ahmed Abdi on May, 24th 2008.

We said that anything less than lengthy prison sentence would be a "mockery of justice."

We know that the defendants have denied all allegations about their suspected involvement with the criminals group in Hargeisa. However, we have sufficient evidence.

We hope that Somaliland justice will open a fair trial against three defendants Mahamoud Doualeh Hersi, Mahamed Isamel Hersi and Abdi Ali Haid in order to restore the law in the breakaway republic of Somaliland.

It's your duty to **capture** wanted **criminals dead or alive** and deliver them to the justice.
