WHAT INSPIRED YOU TO WRITE "I AM A FREE AMERICAN... RIGHT?"

A pressing issue in Arizona, my current home, has been occupational licensing. Governor Ducey has pledged to take on the state licensing boards and we have seen some reform, but these laws are still on the books. What threw me off was a story of a young man in Tucson who was giving free haircuts to the homeless. He was a cosmetology student and it seemed like a win-win service; he was receiving an opportunity to practice his craft while providing a valuable and extremely human and dignifying service to members of his community in need. He was subsequently placed under investigation by the state board, putting his career at risk. We laugh about this kind of regulation, but it truly has a harmful effect on our communities.

There are a lot of silly and outrageous laws out there, many of which have been on the books for decades. So many of them are so bizarre that I couldn't help but laugh at the sheer absurdity of them. What's more interesting to me is the lack of general knowledge the public seems to have of the law. We take it for granted that the law is there to protect us, but the reality is that our criminal and regulatory code seems almost vindictive, to the point that its' hilarious. I spend so much of time writing about bad laws and pestering people with long tirades, that it seemed to be time to put it in a condensed and colorful form that will make folks laugh and question everything they believe about the rule of law.

WHAT DO YOU HOPE TO ACHIEVE WITH THIS SERIES?

Most people seem to have an innate unwillingness to change their minds, especially on the issue of law and order. It's not anyone's fault; we have a difficult time breaking away from what we've been conditioned to believe. Humor, however, has an incredible effect on people. When we laugh together at the same absurdities, we are able to have and extend conversations on topics that would normally end in severe disagreements or stonewalling. Humor is a common ground we all share.

My hope is that this series will encourage readers to research their hometowns and states to see what other kinds of nonsensical legislation is out there. From that mindset, I hope to see more genuine and insightful conversations among individuals, focusing on more commonly-known legislation that is isn't just absurd, but harmful. This is how we enact positive change in our communities; it starts with a dialogue. Why not start it with a chuckle?

WHEN CAN WE EXPECT YOUR NEXT BOOK?

Volume Two is expected out early next year. In addition to Volume Two, I'm looking at an international version with laws from around the world; we all have governments and they all have strange laws that boggle the mind!

The next book in our children's series is due out later this year and will focus on the foundational principles of individual liberty, specifically dealing with voluntaryism, self-ownership, and mutual consent. I'm greatly looking forward to seeing the next book in print as it has been a joy to write.

OUT OF ALL OF THE FEATURED LAWS, WHICH IS YOUR FAVORITE?
