### **State News Updates**

May 21, 2020

- Governor Cuomo held a press conference at 11:30 AM and announced the following:
  - o Total hospitalizations at 5,187 on May 20.
  - o Total deaths increased by 105 on May 20.
  - o Reopening:
    - Rockland County is now eligible for elective surgery and ambulatory care.
  - o Increased activity only leads to increased cases if precautions are not taken.
    - Shopkeepers, employees, employers, and individuals all have a role to play.
  - Essential workers generally have a lower positive antibody test percentage than the general population, which shows masks and other PPE work.
    - If you believe your employer is not following PPE, hygiene, and social distancing guidelines, call the New York Coronavirus Hotline: 1-888-364-3065.
  - o If you get a call from "NYS Contact Tracing" answer that call as that is an official message that you may have been in contact with someone who tested positive for COVID-19.
  - Small Businesses need help:
    - State is extending the sales tax filing deadline to June 22.
  - o Schools:
    - Adopted a statewide policy for schools and closed them all for the rest of the academic year.
    - Schools have high density and transportation issues, and there is greater risk of spread unless protective measures are fully in place.
    - New York State is also investigating 157 cases of what may be a COVID-related illness in children.
      - Last Thursday reported 7 countries have cases, and 17 states and Washington D.C. have reported cases. Now, 13 countries and 25 states and Washington D.C. have reported cases.
    - Summer school this year will be conducted through distance learning.
    - Meal programs and child care services for essential workers will continue.
    - It remains too early to make a determination on the fall semester.
    - State will issue guidelines in June so schools and colleges can start to plan for a number of scenarios.
    - Plans to be submitted to the State for approval in July.
  - o Downstate beaches open tomorrow:
    - Jones Beach, Sunken Meadow, Hither Hills, Robert Moses. Open at 6 AM, close at 9 PM.
       Swimming from 9 AM to 5 PM.
    - Lake Welch Beach (Harriman State Park): swimming open 10 AM to 6 PM.
      - Beaches are limited to 50% capacity, no group activities including sports, areas of social
        gatherings will be closed, social distancing measures will be enforced, masks will be
        required of all employees and visitors where social distancing is not possible, no
        concessions.
  - o It is national EMS Week, and must thank EMS workers who are on the frontlines.
