855.. To receive apologies for absence.

There were no apologies received.

856.. Disclosure of Pecuniary Interests relating to matters on the Agenda.

Cllr. Abbott disclosed a non-pecuniary interest in all items related to ECC.

857.. To approve and sign the Minutes of the meeting held on 3rd December 2013 and the Precept Meeting held on 18th December 2013.

Both sets of minutes were unanimously approved and then signed by the Chairman.

858.. Public Forum for 10 minutes.

The following matters were brought to the attention of Members:

- Litter accumulated at the car parking area at the bottom of the track leading to Tarecroft Wood.
- The removal of the fallen tree near the hotel in Rivenhall End has resulted in the tearing up of the grass verge the Chairman will contact ECC.
- The flooded footway area at the bottom of Stoverns Hill in Rickstones Road has been included in many complaints and requests for repair made to ECC.

859. Matters for Discussion.

i. <u>ECC proposals to expand Chipping Hill Primary School, Witham and Silver End Primary School, with effect from September 2015.</u>

Members made no comment or recommendation regarding this item.

ii. County Highways Maintenance (NOT Local Highways Panel - see item 861(v)).

Members commented on the appalling state of the drains and verges along Rickstones Road – this falls into both ECC Highways maintenance and BDLHP projects.

The many potholes have still not received any attention.

One of the 30mph warning signs in Church Road has been broken and uprooted from the ground.

Rickstones Road - date unknown

Railway Bridge, Oak Road - possible March 2014 Galleys Corner, Braintree - various future dates

Draft examination results are expected by 24th January 2014.

- v. <u>Braintree District Local Highways Panel.</u>
 - (a) Rickstones Road drains and kerbing.

The Chairman has written a strongly worded communication to ECC requesting urgent action to alleviate these problems. Estimated cost £130k.

(b) Railway Bridge, Oak Road.

On track for 31st March 2014 completion, subject to satisfactory detail plans.

(c) 7.5T weight restriction, Oak Road.

Now with Highways Agency for comments but costs have risen up to £70k to include additional signing along the A12 required by the HA. The Clerk is to officially request a detailed breakdown of these costs to explain the vast increase from the original cost of the scheme.

- (d) 30mph along Oak Road & Henry Dixon Road. ECC indicate estimated completion before end of March 2014.
- (e) Church Road additional Bus Stop.
 Currently under construction.
- (f) Hard parking area outside Parish Church.

To be submitted to the Panel at the January meeting.

- (g) Extended 30mph limit along Church Road.

 Initially rejected by the Panel but later re-submitted.
- (h) Extended railings outside School entrance.

To be submitted to the Panel at the January meeting.

(i) 20mph outside the School - for consideration at the next Council meeting.
