Far East Area Commission Completion and Submission of Documentation

How Do I? - Far East Area Commission

On April 27th at approximately 4:45 p.m. Summer Moynihan with the Tussing Block Watch did submit the required documentation consisting of the Far East Area Commission Petition, Far East Area Commission Petition Signatures, Far East Area Commission By-Laws, and the Far East Area Commission Boundaries Map. A copy of the Far East Area Commission By-Laws and the Far East Area Commission Boundaries Map is included at the bottom of this article. Copies of the Far East Area Commission Petition and Far East Area Commission Petition Signatures is available to the public through the Columbus City Clerk's Office at City Hall, 90 W Broad St, 2nd Floor, Columbus, Ohio 43215.

A copy of the City of Columbus Code Chapter 3109 - Area Commissions Procedures for Establishment are also attached. Anyone wishing to object to the proposed documents of the Far East Area Commission will be required by city code to follow the instructions under City of Columbus Code Chapter 3109.03 - Notification of Residents, as indicated below:




3109.03 - Notification of residents.

Within thirty (30) days after filing the petition with its attachments, the task force named therein shall notify residents of the proposed commission area of: (1) the filing with the city clerk; (2) its general provisions including the area boundaries; and (3) the method for objecting thereto. Suitable notice may be given by door-to-door distribution or publication in an area newspaper and shall also be given in The City Bulletin. Within sixty (60) days of such notice, any interested party who objects to the petition, signatures, proposed boundaries, proposed by-laws, rules or selection procedure may file a written objection or an alternate petition with attachments with the city clerk in accordance with C.C. 3109.02. No petition presented pursuant to this chapter shall be considered less than sixty (60) days after notice of its filing has been given to residents of the area.

The Tussing Block Watch will be notifying their community of this process and current status via the TBW Website and this article, in our 4/29/2011 TBW Updates, and through the Neighborhood Pride Center's publication "Neighborhood Notes".
