Driver Education Contract/ Registration form

Requirements for Classroom/ Online instruction (Only required for EOCST program)

- <u>Complete the Virtual Drive (Online)</u>: If school doesn't offer, or student didn't take the Driver Ed class, and student wants to enroll in the EOCST program (KDS administers Driver's Test).
- Students of Hanover, Dover, & Spring Grove are the only schools that KDS can administer the driving test after 6 hrs of BTW training, and the student has completed 30 hrs of classroom/Online Driver Education.
- Completed 30 hour classroom or other on-line course: Copy of transcript (grade/ report card)

Requirements for Behind the Wheel

- A copy of a valid Learner's Permit must be submitted with the registration form: EOCST program.
- Minimum of a <u>24 hour notice of cancellation</u> is required. A fee of \$20.00 may be applied if school is <u>not</u> notified (case by case-life circumstance).
- Payment is required <u>before</u> instruction: If not, training could be cancelled and/or \$20.00 fee may be applied.
- Must receive a confirmation via text/email at least 24 hours notice of scheduled time/date.
- If <u>no confirmation</u> is received, the school (KDS) has the right/obligation to <u>cancel</u> scheduled driving time.
- A certificate of Completion will be issued upon successful completion of the Driver Education (classroom/ 6 hours of BTW). The certificate may be submitted to insurance for a discount.

Requirements for Instructional Driving and Pre-Test Driving

- Student must have a <u>valid permit</u> or license, and must meet all <u>restrictions</u> according to permit and license.
- Additional fee may be applied for training for additional travel time that's over 30 minutes.

Notices:

- 1. Behind-the-Wheel: Payments can be paid in <u>full</u> or in <u>increments</u> before driving lessons (check or cash only).
- 2. A returned check will accrue a fee of \$25.00.
- 3. Krupinski Driving School (KDS) does not guarantee that a student will pass the PennDot driving test after completion of instruction.
- 4. KDS will not refund any tuition or part thereof, if the school has rendered services and has been willing, ready and able to fulfill its part of the agreement.
