

# Terms and Conditions

## Agreement between User and zen-yum.com

Welcome to zen-yum.com. The zen-yum.com website (the "Site") is comprised of various web pages operated by Zen~Yum. zen-yum.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of zen-yum.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

## Cancellation/Refund Policy

Zen~Yum cancellation policy is as follows for all participants such as Vendors, Zen`Yum clients, off site location providers:

Upon completion of a New Guest Registration Form, you are agreeing to the following:

A security deposit paid by client, is due in the amount of \$275 (through pay pal/debit or credit card), cashiers or postal money order at the time of onsite staging appointment. An on site staging appointment must be scheduled within 48 hours of confirmation of confirmation of Event.

Confirmation could take approx 2-4 days, less if needed immediate response due to last minute planning per your event. The security deposit of \$275 is nonrefundable if event is cancelled within 5 days of scheduled date for event to occur. Full refund is given, after event is completed, unless otherwise needed to compensate for any damages beyond normal wear and tear of provided supplies. In addition to compensate for any last minute guest attending the event, shall their fee be applied. If an event is requested within 5 days of proposed dates, client is subjected to immediate selection of meal choices and any added services on vendor's availability. Zen~Yum is only responsible for coordination of event of planning and outside vendors, preparation of food and

staging of yoga mats as discussed at on site visit.

Off site location provider: Cancellation fee of \$175.00 if site location is canceling Zen~Yum event less than 5 days, excluding for emergency reasoning, rather for negligence of booking or miscommunication.

Guest Cancellation:

Zen~Yum is not responsible for any reimbursements of earnest money already paid for and guests that should cancel after initial booking.

Vendor Cancellation:

Each vendor's cancellation policy is described on their personal websites.

Zen~Yum Event set up and break down agreement: Upon arrival 1-2 hours prior to event is permitted, for set up of yoga staging and meal preparation. Client is solely responsible for setting of dining area, staging of lighting, any beverages (alcoholic/nonalcoholic)
