Our training program certifies bail agents and other members of the bond industry to perform Event Interventions on their clients that are facing consequences due to their addiction.

Recent studies have shown that:

***Alcohol and drugs are implicated in an estimated 80% of offenses leading to incarceration in the United States**

- 80% of offenders abuse drugs or alcohol.
- Nearly 50% of jail and prison inmates are clinically addicted.
- Approximately 60% of individuals arrested for most types of crimes test positive for illegal drugs at arrest.

Given these statistics, it becomes obvious that addressing the addiction is a principal concern in efforts to reduce recidivism and rehabilitate those involved in criminal activity. As trained Interventionists, bail agents can facilitate clients going into treatment both while on bail, or as part of a furlough program. Either way, the clients whom go into treatment will be monitored and fully accountable for their actions. Courts will see levels of success with offenders that otherwise are not attainable.

Our Certified Event Interventionists are trained in, effective communication, addiction recognition, conflict de-escalation and in co-operation with the American Addiction Institute, client placement.

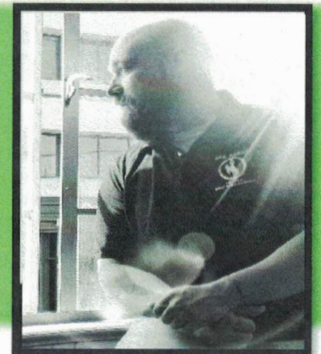
