Bowenwork is a very effective and gentle form of bodywork. Gentle moves are performed over muscles and soft tissue, stimulating the nervous system to reset and heal. Frequent pauses in between moves allow the body to process the messages and initiate the healing process. You may notice changes over the next several days as your body continues the process. The process can continue up to 10 days after the session.
