      - 4. Two ground projects: The Garden, and general buckthorn removal
      - 5. FOBL should use a 12 month calendar
      - 6. Two administrative committees needed
  - e. The committee to work on the bylaws includes: Don, Nancy, John and Joelyn
- 9. **Diane** has made phone calls to prospective members with some success this is the first effort to actually call volunteers/members to invite them to be an active member or board director of FOBL.

She used the various lists we have to make the phone calls.
