1. _____In order to enroll for the upcoming school year co-op, families must pay 1 month tuition as a non-refundable deposit. However, once the child begins the school year as a full-time student, that deposit will be applied to the last month of school tuition in May. Enrollment after April 1st for the upcoming school year includes a \$100 registration fee. There is no Enrollment fee of \$100 before April 1st for upcoming school year.

2.____ If a family pays in full, they will receive a 5% discount on their total tuition. However, if the student drops before the end of the year, the family will forfeit the discount and be obligated to pay the tuition of the last month that the student was enrolled in school even if the student does not complete the entire month, and will also be assessed a \$580 early withdrawal fee.
