Deposit Information

- 1. A non-refundable 50% deposit is required to confirm booking.
 - a. Deposits may be transferred to an alternate date under certain extenuating circumstances. Such as the current COVID-19 pandemic.
 - b. Deposits may be refunded to the CUSTOMER under certain extenuating circumstances. Such as the current COVID-19 pandemic.
- 2. No order will commence until the deposit has been paid & received.
- 3. Quotes will remain active for SEVEN (7) days OR up to SEVEN (7) days prior to the EVENT DATE; whichever one is lesser.
- 4. Once deposit had been paid, the quoted price remains fixed to the details in the quote. (see CHANGES TO ORDER)

Changes to Order

- 1. If the customer requests changes to be made, they must be made at least FIVE (5) days prior to the EVENT DATE.
- 2. Any changes requested at least FIVE (5) days prior to the EVENT DATE will be subjected to a new QUOTE and an additional deposit payment may be requested.
- 3. Any changes requested within FIVE (5) days of the EVENT DATE cannot be guaranteed and may be subject to additional charges
- 4. A 25% SHORT NOTICE FEE may be applied to any order changes applied within FIVE (5) days of the EVENT DATE.

Balance Due

1. The remaining balance is due upon delivery/pick-up.

Environment

- 1. Client is responsible for providing an appropriate and secure table and environment for the order. Orders can be heavy and require a sturdy table and optimal room temperature of 21°C (70°F) or below.
- 2. High temperatures can adversely affect your order. Baker is not responsible for orders that are placed outside in warm weather. If the order is placed outside it will be at the Client's own risk.

Pick-up

- 1. If you or your representative elect to pick up and set up the order, you assume all liability and responsibility for the condition of the order once it leaves our possession.
- 2. If the customer fails to pick-up the order at the agreed upon date/time, without prior communication, the customer will forfeit their deposit and order.
- 3. The customer will be granted a thirty (30) minute grace period for pickups. (EXAMPLE: If we agreed you would pick it up on Monday @ 4:00-4:30, I will wait for you until 5:00.)

 - c. Sundays and STAT Holidays are not available for PICK-UP or DELIVERY

- 4. The customer will be granted a ten (10) minute grace period for pickups. (EXAMPLE: If we agreed you would pick it up on Monday @ 4:00-4:30, I will wait for you until 4:40.)
