#### **GUIDELINES FOR APPROVING CHARITABLE PROJECTS**

### Who are we?

We are a professional group of Registered Nurses, Midwives & Health Visitors from Cameroon who live and work in the UK. Each member has a current registration with the Nursing & Midwifery Council in England – NMC

### What is our Aim?

Our aim is to support organisations or a group of people that have effective plans, goals and ambitions in helping those most in need in Cameroon or the United Kingdom – UK.

### About these guidelines

We appreciate the time and effort that fundraising takes and aim to be as clear as possible about what the group does and doesn't fund, how to apply for a grant and how long the process typically takes.

These guidelines are divided into three sections.

### Who we support

The group will support Cameroon or UK registered charities working within the areas of Welfare, Youth, Community, Arts, Faith, Environment, Education and Health & Heritage.

## What the group will fund

The group will fund both capital and activity expenditure.

The group's maximum capital per project will be 500pounds

The group will not fund more than two projects over a 12months period

Health projects

- Educational projects
- Training projects
- Projects that delivers training to schools
- Projects that delivers training to health clinics which are not own by government or individuals
- Environmental projects that benefits a local community for example a disadvantage community
- Humanitarian aids to displaced groups or families due to natural disaster, war or conflicts

## What the group will not fund

- Individuals except disadvantage children of school age
- Charitable Incorporated Companies (CICs)
- Social enterprises without Cameroon or UK Charity Commission registration
- sporting associations that are not registered charities
- work that does not deliver a direct benefit in Cameroon or UK, even if the organisation is a registered charity within those countries
- animal welfare charities
- charities that spend the majority of their income outside Cameroon and the UK
- local authorities, councils, local government and government agencies
- Profit making organisations & businesses
- Individual business

## The application process

This section outlines everything we need to see in a funding application, how to submit your application and what happens next.

- Applications for projects will be via members within the group whose membership fees is up-to-date
- For Each project, a CNA project application forms needs to be completed by the project lead
- Applications for projects should be made directly to the association three months in advance to the association's AGM
- Each application needs to be discussed by the association in two monthly meetings in advance of the association's AGM
- The selected projects by the group will be declared or announce at each AGM
- For each project agreed and funded by the group, the project lead will give the group a verbal two monthly update of the progress and must agree to provide a full report on your project within 6 months of the completion of the project – photographic evidences as feedback will be highly encourage.
- Where the group fails to reach a majority consensus or decision on which project to select, a patron will be co-opted to assist in the decision making.
