
A BYLAW TO ENTER AN AGREEMENT WITH THE MOOSE CREEK RECREATION ASSOCIATION

The Council of the Rural Municipality of Moose Creek No. 33 in the Province of Saskatchewan enacts as follows:

1. The Reeve and Administrator are hereby authorized to enter into the Agreement attached and identified as Schedule "A" to this bylaw, with the Rural Municipality of Enniskillen No. 3 and the Towns of Alameda and Oxbow operating as the Moose Creek Recreation Corporation for the purpose of providing funds as described in the agreement.
2. This bylaw shall come into force upon its final passage by Council and its approval by the Local Government Committee.

**Moose Creek Recreation Corporation
Funding Agreement**

This Agreement made this 14th day of July, 1998

BETWEEN

The Rural Municipality of Enniskillen #3 in the Province of Saskatchewan, hereinafter referred to as "R.M.#3"

the party of the first part

-and-

The Rural Municipality of Moose Creek #33 in the Province of Saskatchewan, hereinafter referred to as "R.M.#33"

the party of the second part

-and-

The Town of Alameda in the Province of Saskatchewan, hereinafter referred to as "Alameda"

the party of the third part

-and-

The Town of Oxbow in the Province of Saskatchewan, hereinafter referred to as "Oxbow"

the party of the fourth part

WHEREAS the parties named above have formed a non profit corporation known as the Moose Creek Recreation Corporation for the purpose of building and operating a Park on the Alameda Reservoir;

AND WHEREAS the parties desire to ensure a long term funding commitment to this corporation

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration these presents and the covenants, promises, and agreements hereinafter contained, the parties jointly agree as follows:

1. To Continue to associate and work together and appoint representatives to the Moose Creek Recreation Corporation to further develop and maintain the Park.
2. To Continue to develop, operate and maintain the area of land used for the Moose Creek Park described as Sections 15 and 16 in Township 4 in Range 2 West of the Second Meridian

3. To Provide funding to the Moose Creek Recreation Corporation as follows:


R.M.#3	\$5,000.00 annually for the years 1998 through 2001
R.M.#33	\$5,000.00 annually for the years 1998 through 2001
Town of Alameda	\$1,500.00 annually for the years 1998 through 2001
Town of Oxbow	\$5,000.00 annually for the years 1998 through 2001


4. The Parties each agree to do all acts necessary in order to confirm this agreement and in particular, the parties agree to pass a complimentary bylaw authorizing the execution and performance of this agreement.

5. This agreement shall be renewable as of January 1, 2002 should the municipalities participating under this agreement so desire.




R.M. of Moose Creek #33





AUTHORIZATION TO A RURAL MUNICIPALITY TO INCUR A LIABILITY

HAVING RECEIVED APPLICATION from the council of the **RURAL MUNICIPALITY OF MOOSE CREEK NO. 33** for permission to the passing of proposed Bylaw No. **4/98** authorizing council to enter into an agreement with the **Moose Creek Recreational Association** for the purpose of building and operating a park on the Alameda Reservoir thereby creating a liability not payable within the current year.

AND being satisfied that all the requirements and provisions of *The Rural Municipality Act, 1989*, and of *The Municipal Board Act* with respect thereto have been complied with;

THE LOCAL GOVERNMENT COMMITTEE under the authority vested in it by the said Acts, hereby authorizes the said council to pass proposed Bylaw No. **4/98** authorizing the council to enter into an agreement providing for the creation of a liability of **TWENTY THOUSAND DOLLARS (\$20,000)**, payable in annual instalments of \$5,000 for the years 1998 through 2001.
