



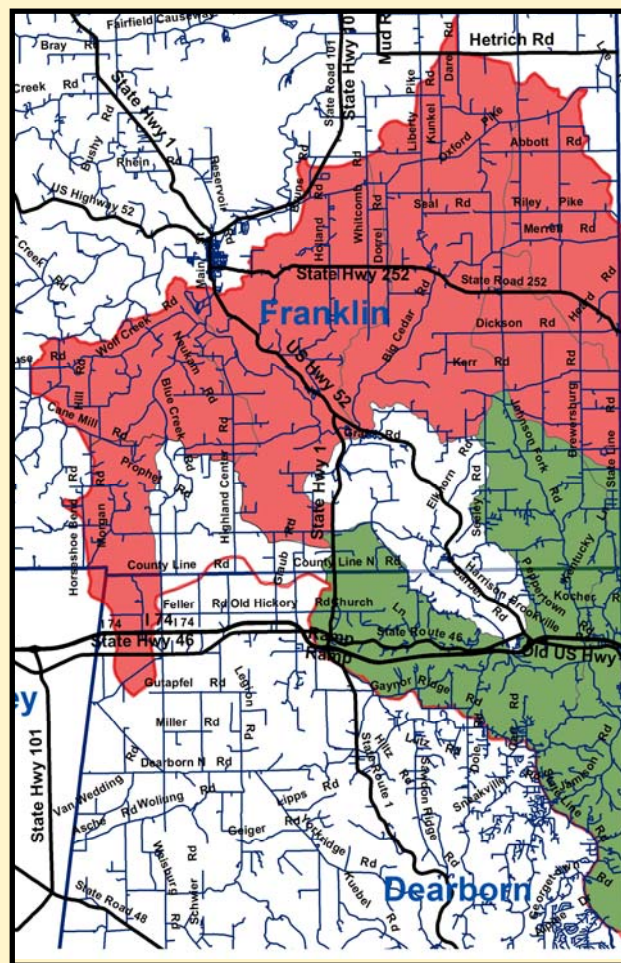

Whitewater River Watershed Cost-Share Update

The Whitewater River Watershed Project is halfway through its first implementation grant period. The project received \$200,000 to provide cost-share to landowners to install best management practices in the watershed's critical areas to help improve water quality. During the first half of the grant period only applications in the high priority critical areas could be funded. The steering committee has funded 16 applications so far and has allocated \$128,000 of the cost share money. Since we are now halfway through the grant, the steering committee would like to give applicants located in the medium priority area a chance to receive

funding. Now anyone located in the red or green areas in the map, are now eligible to receive 70% cost-share to install best management practices up to \$8,000 per applicant. To the left is the list of available practices and

the not to exceed rates per practice. All practices must be completed according to NRCS (Natural Resources Conservation Service) FOTG (Field Office Technical Guide) specifications. Many practices are engineered and must be installed according to the designs provided. Payment is a reimbursement and typically takes 4-6 weeks after paperwork is sent to IDEM. Landowners are responsible for paying for all materials and contractors after the work is completed. All practices and paperwork must be completed and submitted by January 2020.
