## 1916. Apologies for Absence.

# 1919. Discussion and Agreement of the proposed budget items for year 2020/2021.

The Clerk had, with the agenda, distributed to each Member copies of his budget estimate to 31 March 2020 and for the year 2020/2021.

Following a brief discussion it was proposed by Cllr. Wright, seconded by Cllr. Prime and agreed with one abstention that the following Budget figures be agreed for the year 2020/2021:

i.	Parks & Open Spaces.	£7,425.00
ii.	Administration.	£8,417.00
iii.	Payments made under Section 137.	£120.00
iv.	Reserve Fund	£7,000.00

## 1920. Requirements under the Audit Regulations.

i. Appointment of Responsible Financial Officer (RFO).

Proposed by Cllr. Abbott, seconded by Cllr. Wright and unanimously agreed that the Parish Clerk continue as the Responsible Financial Officer for the year 2020/2021.

ii. Appointment of Internal Auditor.

Proposed by Cllr. Abbott, seconded by Cllr. Wright and unanimously agreed that Mrs Ann Clarke be reappointed Internal Auditor for the year 2020/2021.

## 1921. To set the Precept for the year 2020/2021.

Taking the budget figures at item 1919 above, the proposed budget for 2020/2021 is £22,962.00 excluding £7,000.00 from reserve funds for any major/capital expenditure. Less the BDC's estimated Street Cleaning Grant of £1915.00 the estimated budget expenditure for 2020/2021, therefore, is £14,047.00 .

Proposed by Cllr. Abbott, seconded by Cllr. Prime and unanimously agreed a Precept amount of £12,000.00 to be levied for the year 2020/2021.

This gives an estimated Band D equivalent Council Tax of £44.86, £1.19 more than 2019/2020.

This Budget and Precept was recommended for final approval at the next Parish Council meeting on  $7^{th}$  January 2020.
