This form is intended as a simplified, standard mechanism for businesses to initiate contact with a municipality concerning their activities within that city. SECTION 15 – It shall be unlawful for any person, firm, corporation, company association of profession to engage in any business, vocation, occupation, profession or perform any act in the City of Odenville and/or within the police jurisdiction thereof, as provided in this ordinance without having first procured license thereof, and each day during which said business, vocation, occupation, profession or act is engaged in shall constitute a separate office.

SECTION 29 – Any person, firm, or corporation failing, neglecting or refusing to have the Town license required under this ordinance posted conspicuously at the place of business for which the license was obtained or to have the same duplicate thereof in actual possession if an itinerant, shall pay an additional tax of \$25.00 each and every separate offense and each days failure, neglect or refusal shall constitute a separate offense.
