

PRIVACY STATEMENT PURSUANT TO ART. 13 OF LEGISLATIVE DECREE NO. 197/2003

Dear Madam/Sir

we inform you that Legislative Decree n. 196 of 30 June 2003 ("Code regarding the protection of personal data") provides for the protection of persons and other subjects regarding the processing of personal data.

Under this legislation, the processing of information relating to you will be based on principles of correctness, lawfulness, transparency and protection of your privacy and your rights.

We inform you that the personal data you give to us when you make a reservation for the apartment, located in Via Giacomo Parascio n. 3, ground floor, Delebio (SO) or any ancillary services, or when you ask for information via the website www.valtellinaguesthouse.com or via E-mail at info@valtellinaguesthouse.com or other means, will be used for purposes strictly necessary and related to the activities that are needed to provide the information and/or relating to your booking, depending on how you have requested.

Providing your personal details is necessary because, without them, we can not act on your request for information or reservation request.

The data you have provided will be processed in order to fulfill, in general, legal obligations, including those of a fiscal nature, and the disclosure requirement of the personal data of residents to the Police Headquarters of Sondrio (service "Alloggiati web").

Any refusal to provide such data will make it impossible to use the Services only accessible by users of the Site.

Method of treatment: the personal data will be processed on paper or magnetic or computerized, using the appropriate measures to ensure the security and confidentiality of the data.

Your data may be disclosed to other entities within the scope of the service offered, to fulfill the obligations of the law, but not in any way be subject to disclosure to third parties for commercial purposes, as these data will be aware only the owners/landlords of the apartment leased for tourism (and individuals appointed by them), and may, with the express approval optional, to be used by them to send you information concerning its activities or special offers.
