**PLEASE NOTE:**

THE REGISTRATION FEE AND THE LAST MONTH'S PAYMENT ARE **NON-REFUNDABLE**. THERE ARE NO REFUNDS FOR MISSED CLASSES. MISSED OR CANCELLED CLASSES (IE: in the event of bad weather) CAN BE MADE UP.

**PLEASE NOTE:**

Monthly fees represent 1/10 of the dance year. **They DO NOT represent 4 lessons.** Due to holidays, etc. there are months when some classes will meet more than others, however, during the course of the entire dance season, each class will meet an equal number of times.
