The owners and staff are committed to your athlete's growth and success. No experience is necessary and everyone will be placed on a team. VCC will teach your athletes at all levels! We will work with each athlete to ensure a fun and safe environment. Each athlete will learn: jumps, stunts, tumbling and dance. Plus, we plan on them learning life lessons that will carry them to adulthood like: teamwork, setting goals, building lasting friendships, time management, accountability and more! We will provide a family friendly atmosphere and encourage your athlete to reach their highest potential.

Crossover Athletes (additional \$50/month)

Athletes may be asked to participate on two teams. Crossover athletes are typically used to fill specific spots that are open on teams. If your athlete is asked to crossover to a second team and you accept spots on both teams, you are obligated to pay the higher monthly tuition as well as the additional fees (practice wear, choreography/music, competition fees, etc.) associated with crossing over. Crossovers may not be finalized until choreography.

Athletes are required to maintain the skills displayed at evaluations. Athletes make teams based on skills and performance. Skills will be continually evaluated throughout the summer. Adjustments may be made to teams at any point in time if athletes do not maintain their skills.

Discounts: Sibling Discount: \$75 off per month for each sibling after the first full paying athlete for tuition. Discount does not apply to uniform, practice wear, warm ups or competition fees.

Auto Payment Enrollment (25th of every month): \$10 off per month. (team athletes only)

Loyalty Discount: An additional \$5 off per month. (have been with VCC for 3 seasons.)

Placements:

We will place each athlete by level as closely as we can. Please keep in mind there are many factors we must decide upon when placing each athlete on a team, such as: number of athletes, stunting, jumps, tumbling, dance and age. Each position on a team is just as important as another. Every athlete is on a team for a reason. Please trust our staff and their decisions.

Athletes are expected to improve their skill level throughout the season. The coaching staff may require an athlete to take extra technique classes to build skills if they wish to remain on the team they have been placed. If an athlete does not maintain or achieve the skills necessary to compete at the level of the team they have been placed on, the athlete may be placed on a different team, suspended or removed from the team.

Evaluation Attire:

Please wear black shorts, black sports bra or tank top. Any VCC practice wear or attire is acceptable. Have your hair pulled back in a ponytail if it is longer than your shoulders. You may wear your own bow or bows will be available to purchase at the gym. Each athlete must wear athletic shoes or cheer shoes. Age appropriate makeup. No jewelry.

What do I need to bring to evaluations:

- Copy of athlete's Birth Certificate
- Copy of athlete's insurance card
- Parent/Guardian's ID
- Tryout Form and Registration
- Head Shot / School picture
- Gym Policies and Code of Conduct signed
- Completed Financial agreement with credit card information. (A credit card must be kept on file.)
- Signed tryout packet
- \$50 tryout fee per family

What if I can't make tryouts?

You may schedule a private tryout for a later date. An extra fee may be required. For a private tryout please email admin@vegascheercompany.com to set up a time.

CHOREOGRAPHY

All music, cheers, dances, stunts and any choreography or ideas that are presented to the athletes during practices are to remain confidential and should not be discussed, taught or given to others outside of our program. An athlete may not use any Vegas Cheer Company material for their school team or other teams they may help coach. No one is allowed to post VCC music, choreography, routines, stunts, etc on any websites. This includes, but is not limited to "Instagram", "Facebook", "Twitter", "Snapchat" or "YouTube". All decisions on the choreography of the routine are made in the best interest of the team.

Joining Late: You will be back charged the non-tuition portion of each monthly payment starting in June until the month you begin. Full tuition will be paid for the rest of the season. If you join late you may not have the opportunity to receive the items ordered previously in the season, charges will be adjusted accordingly. Fees for the previous months will need to be paid and the account current upon team placement for the athlete to begin practicing.

- ❑ Monthly fees are due on the 30th of the prior month. There will be a \$25 late fee if not paid by the 8th. Vegas Cheer Company team members will receive 50% off tumbling and specialty classes. Elite team members receive unlimited tumbling classes only, this does not include specialty classes. (ie. flexibility, flying classes etc.)
- ❑ A USASF profile is required for every athlete competing at USASF sanctioned events. Each family is responsible for creating a profile for their athlete(s). This includes a \$30 USASF membership fee per athlete. A copy of the athlete(s) birth certificate and a current picture must be uploaded to every profile. This membership is valid for one season and is required to be renewed every season.
- ❑ Cheer shoes can be purchased through the gym at any time or at Nfinity Night. The time and date of Nfinity Night will be announced in June. Any type of **BLACK** Nfinity cheer shoe may be purchased for competition. Practice shoes may be white or black. Shoes can also be purchased online. Cheer shoe sizes run smaller than street shoes, it is recommended to go two sizes larger than your athlete(s) normal shoe size.

Financial Agreement

I, _____, understand that I am entering into a binding agreement with Vegas Cheer Company, LLC (VCC) for cheerleading/tumbling services for my minor child _____, commencing on May 15, 2020 and ending on May 31, 2021. I understand that I am obligated to pay the monthly Fees from June 2020 through May 2021. The cost of optional items or additional classes/clinics is not included in the monthly fee and payment for such items will be added to my monthly statement.

By signing below, I agree to abide by all of the terms and conditions herein, as well as all rules and requirements provided in the VCC Information Packet. Payments are due on the 30th business day of each month. Payments may be made in person or by enrolling in auto payment. Payment may be made by cash or credit/debit card only. Absolutely NO checks will be accepted. Payments not received by 8pm on the 8th day of the month will be considered late, the option to pay by cash will be forfeited, and the credit/debit card on file will be charged all monthly fees in addition to the \$25.00 late fee. These charges will be automatically withdrawn no later than the 15th business day of the month. If a payment arrangement, other than the one outlined above, is necessary, a separate agreement must be signed and approved by management.

Initial Here

Monthly payments will follow the payment schedule above unless additional classes are added. The monthly fee does not include: backpack, optional merchandise, additional camps/clinics/classes, private lessons, cross-competitor fees, USASF fee, travel expenses, or parent/guardian entrance to competitions. Competition fees are collected in advance of the competition and are nonrefundable should an athlete not compete for any reason.

Early termination of this agreement will result in a Termination Fee. If termination is on or before October 31, 2020, I have the choice of paying a \$500 Termination Fee per team on which the athlete participates *or* immediately return the uniform, *so long as the uniform is in good & usable condition*. Termination on or after November 1, 2020 will result in a \$1,000 termination fee per team on which each athlete participates. **The Termination Fee is payable immediately upon termination.** If you choose to withdraw from the program for any reason, you must notify VCC in writing at least 10 days prior to the next month's billing cycle. Failure to do so will result in the next month's fees to be charged and collected in addition to any applicable Termination Fees.

Penalty fees for unexcused absences or missed competitions are due at the next billing cycle. No refunds will be given for any reason. Accounts may be credited for cancelled competitions, camps or other expenses and may be used as gym credit only. All credits applied to accounts may be used toward the monthly fees only. Unused credits will only remain on the account for 6 months. After the 6-month period has expired all unused credits will be forfeited.

Any/all balances left outstanding upon completion/withdrawal of services will be charged to the above card. If at any time the above card is declined, or the account becomes delinquent, services and any tangible orders will be ceased until full payment is received. Athletes will be asked to sit out of practices/events if payment is still outstanding on or after the 8th of each month. If a third party (not a party of this agreement) is responsible for payment of some or all of the fees associated with this agreement, an additional and separate financial agreement must be signed by such a party. If the third party payee defaults on payments, the parent or guardian signing this primary agreement becomes completely financially responsible for the remaining term of the agreement. I furthermore agree that any changes made in accounts and/or credit/debit card providers, card numbers, expiration dates etc. will be reported to Vegas Cheer Company, LLC in order to update such records and to avoid any delay in services. Failure to provide VCC with updated card information will result in a \$25 fee charged to your account for each occurrence.

Gym Rules

- No food, drinks, and candy should be brought into the gym or on to the practice floor. Water and Gatorade is permitted if it is closed and is placed in designated areas.
- Gum is strictly forbidden in the gym.
- Parents, siblings, relatives, etc. may not enter the gym area without the permission of the coach.
- All spectators will view classes and/or practice from the viewing area. -Gossiping and other negative talk will not be tolerated. If such talk occurs that person will be asked to leave.
- Negatively confronting a staff member will not be tolerated. Appointments need to be made to address any concerns you may have. We can not help resolve an issue if we do not know it is happening.

Behavior and Attitude

- Parents, athletes and staff are expected to set a positive example whether in or out of uniform. This includes in person, on the telephone and on the computer (this includes the internet and phone messaging). Negative comments on Facebook, Twitter, Instagram, SnapChat, GroupMe, message boards or the like will not be tolerated.
- Any type of bullying or negative behavior will not be tolerated. This includes, in person, phone calls, any type of social media etc.
- Parents and athletes are not permitted to contact competition companies, or any other VCC merchants by phone or email.
- Any illegal activities such as drugs and/or alcohol will not be tolerated at any time. Athletes suspected of being under the influence of any controlled substance or alcohol will be immediately terminated from the program. Coaches and or Owners will contact parents immediately.
- Participation in any activity that can jeopardize the name and/or reputation of the athlete and/or the VCC program will result in termination from the program.
- Respect toward VCC staff members, teammates, and parents, is not an option, it is an expectation. VCC staff will show you the same respect. Anyone found to disregard this expectation will face disciplinary action.
- Team placement will be accepted in a dignified manner with no criticism or comments.
- Excessive behavior problems will lead to a required parent/coach conference and could result in suspension or removal from the team.
- Parents and Athletes are asked to always show good sportsmanship, positive conduct and professionalism at all competitions and practices even when good sportsmanship is not shown to you. In return Vegas Cheer Company Staff and Owners will ensure that good sportsmanship and positivity is demonstrated and encouraged on their behalf.
- No profanity or rude language will be tolerated in the gym from athletes, staff, or parents. Such behavior can result in dismissal from the program.
- Practice schedules can be changed at the discretion of the owners/coaches. We will add practices before competition if necessary to their overall success at the upcoming event.

Attendance

- ❑ All practices are mandatory unless prior arrangements have been made with your athlete's coach. This is a team sport and we do not have replacements if your athlete is absent. Excused absences include: illness (fever, vomiting, strep throat etc. If your child is contagious, please keep them home) death in the family. We expect athletes to attend practice if they have the sniffles or mild cold. If the athlete is injured and has proper doctor notes to attend practice, we expect them there even if they sit out. It's important they are there if there are any changes to the routine.
- ❑ Excessive absences both excused and unexcused could lead to removal from a competition or removal from the team at the discretion of VCC staff.
- ❑ All unexcused absences 2 weeks before a competition will result in a fine of \$50 being charged to the athlete's account for each occurrence and is payable when the next payment is due. This includes extra practices. Expect that extra practices will be added in these weeks. Athletes missing practice 2 weeks before a competition may be removed from a competition at the coach's discretion.

Tardies

- ❑ DON'T BE LATE, please. Tardies may result in extra conditioning for the team and/or individual at the coach's discretion. Excessive tardies and/or tardies of more than 30 minutes will result in a \$15 fine. A fine of \$25 will be assessed 2 weeks before competition.

Practices

- ❑ Practice days and times will be announced after team placement.
- ❑ All female athletes are required to wear their hair in a ponytail. All athletes must wear tight fitted clothing in our team colors which include teal, purple and black. Once practice clothes arrive, practice wear will be required during team practices.

Private Lessons

- ❑ Days and times available may vary. Up to 3 athletes may share a private lesson. Any communication about the changes or cancellations should be handled directly through the front desk or with coaches. We strongly recommend that every athlete participate in either classes or private lessons. While we will spend a portion of our team practices on individual skills, athletes will progress much more quickly if they are also getting instruction outside of their actual practice time. Accounts must be current in order to participate in private lessons.

Injury and Medication

- ❑ Any/all medical conditions and/or medications must be reported to the team coach and VCC. Athletes who require the use of an inhaler must have it available at all practices and competitions. All injuries must be reported to a coach or staff member immediately. Injuries that prevent an athlete from participating in practice do not excuse them from attending practice, unless the injury prevents attendance through doctor's orders. Upon returning from an injury/illness, athletes are required to provide a signed doctor's release stating they are cleared for participation in practice.

Competitions

- Competitions will begin in December 2020 and continue through May 2021. Competitions are either one or two days. There will be approximately 5-8 local and/or out of state competitions. Attendance at all competitions is mandatory. Competition fees are non-refundable should an athlete be unable to participate for any reason. If a replacement athlete fills in for your athlete, all awards awarded to the team will be awarded to the replacement athlete, not the original competitor. Missing a competition or any VCC performance event will result in a \$500 fine being charged to your account, which will be due at the time of your next payment. A team schedule will be sent via email during the week prior to the competition. The schedule will set each team's meeting, warm up and performance times.

Travel Procedures

- Parents are required to make travel arrangements and hotel accommodations for their athlete when competing outside of the Las Vegas area. All athletes **MUST** be chaperoned by a parent/guardian throughout the length of the out of town trip. If a parent cannot attend an out of town trip with their child, they are expected to find a proper chaperone for their child to travel with. No athlete under the age of 18 may travel without a chaperone. Some competitions require block hotel booking through a housing service. All families must book through the VCC contracted hotel blocks in order to compete. If VCC should choose to travel as a team, athletes must stay in the room assigned to them by the VCC staff. Athletes are expected to respect and abide by all rules set forth by the VCC Staff and chaperones.

Gym Closures:

- Labor Day September 7, 2020
- Nevada Day/Halloween October 31, 2020
- Thanksgiving BreakNovember 23-29, 2020
- Winter BreakDecember 21, 2020 – January 3, 2021
- Spring Break March 29, 2021- April 2, 2021

Coaches may choose to have practices on these days if it is close to an upcoming competition.

Miscellaneous Rules and Guidelines

- VCC coaches will place athletes on the team that is best for the athlete and/or team.
- Team placement is not up for discussion.
- It is solely up to the coaches to decide if an athlete can do more than one team.
- The VCC coaching staff retains the right to remove or replace a team member at any time throughout the year.
- I agree to inform the front desk of any address, credit card, or email changes. -All changes except for credit card changes may be e-mailed to admin@vegascheercompany.com
- Failure to follow the above rules or behaving in a manner that jeopardizes the name Vegas Cheer Company can lead to removal from the team.



As a VCC parent, I understand the responsibility and commitment that my son/daughter is undertaking. I have read this agreement and understand its contents. I have also gone over the rules and expectations with my athlete. I agree to abide by the VCC rules and regulations and ensure that my son/daughter does as well. I agree to support the VCC program and offer encouragement to my athlete's fulfillment of all their responsibilities. I agree to allow my child to participate in all VCC activities and will be cooperative carrying them out. I understand that this program is a commitment on the part of the parent as well as the athlete. I agree to help my child fulfill this commitment. Furthermore, I will not use this program as a form of punishment for my child as I realize that it also punishes the team. I also realize that when I am at a function with the team I represent VCC and therefore must always act with class and responsibility.

I realize that all program decisions concerning athlete team placement, choice of competitions, uniforms, team level etc. are completely up to the VCC Staff and parent interference or bad mouthing will not be tolerated and may result in the removal of the parent and/or athlete from the program. I understand that all athletes or athletes whose parent(s) are consistently negative, found gossiping or have caused numerous problems could be removed from a team regardless of the athlete's talent level or attitude. VCC parents and athletes are expected to be part of the solution and not the problem by making an effort to stop others from gossiping. VCC reserves the right to use discretion in enforcing the provisions of this agreement.

TRADEMARK AND LOGO REGULATIONS

The name "Vegas Cheer Company", team names and the logos are the property of Vegas Cheer Company, LLC. and are protected under law. Permission is required before anyone may produce or sell any product that uses or displays our name or logo. All sales involving Vegas Cheer Company merchandise must go through Vegas Cheer Company, LLC. No one can produce ANYTHING with the words "Vegas Cheer Company", "VCC" or the logo without written permission. All items produced displaying team names must also be approved. Furthermore, once permission is granted, all final designs must be approved before they can be produced. Any violation of this may result in dismissal of athletes from the Vegas Cheer Company program.
