# **Term of Agreement**

- 4. The terms of this Agreement (the "Terms") will begin on the date of the signing of this Agreement and will remain in full force and effect until the completion of Services, subject to earlier termination as provided in this Agreement. The Terms of this Agreement may be extended with the written consent of the parties, (e.g. services provided to regular customers).
- 5. The Contractor's Terms and Conditions regarding the services provided are listed in the Contractor's website: Excellencecleaningpros.com. Client can view the most current version of these *Terms and Conditions* by clicking on the "More" tab and selecting "Terms and Conditions." It is Client's sole responsibility to read and fully acknowledge such Terms and Conditions to clarify any questions or concerns regarding the Contractor's services.

## **Capacity/Independent Contractor**

6. Excellence Cleaning Pros. holds commercial liability insurance with Hiscox Insurance Company INC. Policy No. UDC-2257169-CGL-18. Under this Agreement it is expressly agreed that the Contractor is acting as an independent contractor and not as an employee and it's exclusively a contract for service, (Terms & Conditions).

- 7. In the case that the Contractor and any of its affiliates should suffer any minor or serious injury while on the job, neither the Client nor the Client's home/property will be held responsible or liable.
- 8. However, Client must provide with a safe work place for the Contractor and its affiliates. Including but not limited to clear paths to designated work stations (i.e. personal items must be put away), homes free of pests, aggressive animals must be kept no less then 10 feet away from Contractor's pathway and work areas, and home temperature must be no higher then 80°F. In the event that the Client doesn't comply with the Service Agreement, the Contractor has the right to refuse service and any deposits will be none refundable.
- 9. There will be an additional charge if Cleaners have to pick up items from the floor in order to vacuum.
- 10. It is the Client's responsibility to warn Contractor of any fragile items, including but not limited to, items that can be easily damaged. Contractor holds not responsibility for minor damages or accidents cause by service, nor will be responsible for lost items. It is Client's sole responsibility to put valuables away. For more details please refer to our Terms & Conditions.

#### Compensation

- 11. Payment for service must be given before Service begins to avoid misunderstandings.
- 12. Total Compensation for service will be decided after inspection and when all final additions (requests not included in package) agreed on are finalized. Deposit will be deducted out of the total.
- 13. The Contract will be honored as a form of receipt for the Contractor and Client.

#### **Completion of Job Guarantee**

14. ECP offers a Completion of Every Job Guarantee, the "Guarantee", to all customers if and only if customer agrees to our Initial cleaning rate estimate, (\$30/hr/cleaner) according to the time estimated by supervisor. The Guarantee, guarantees that cleaners will stay additional time, if necessary, to finish and wrap up (up to 15 mins/hr of paid service), or give a credit for next recurring service (Up to \$50). However, the Guarantee is not applicable when customer chooses an arranged quote that will better fit their budget. Therefore, in order to fit job into customer's budget, estimated time must be reduced accordingly and the Guarantee will not be applicable and service will be concluded when the estimated budgeted time is up.
