

1. Purpose of the Memorandum of Understanding

This Memorandum of Understanding is intended to articulate the roles and expectations of the parties and provide the terms of the collaboration between Enrich the Mind Foundation, the Ministry of Education, Matilda Newport Junior High School, to support the national education goals through the Adopt-a-School program.

2. Background - Adopt-a-School Program

The Ministry of Education (MOE) in its commitment to the provision of quality Basic and Secondary Education, seeks innovative programs that gives private and business institutions and individuals the opportunity to become partners in education by providing assistance in the upgrading and modernization of its public schools. The Adopt-a-School Model of partnership will generate investments and support to education outside the mainstream funding and the national budget.

3. Background – Enrich the Mind Foundation (ETM)

Enrich the Mind, a 501 (c) (3) nonprofit organization, registered in the U.S. and in Liberia. It was established to improve the educational outcomes of students in Liberia. This organization was born from the belief that education is the best remedy for poverty, and other social ills that plague the country; and our passion to help ensure that the youth of Liberia get the best education possible. Our vision is to unlock the full potential of our youth - one mind at a time - by championing literacy and equity in education.

Our Mission: Enrich the Mind partners with the Government of Liberia, local communities and schools, and partner organizations to develop sustainable solutions to the challenges faced by Liberia's education sector and improve learning outcomes. To help achieve this goal we focus on bridging the resource gap to improve literacy and the conditions for teaching and learning in schools across the country

Goal: To increase the youth literacy rate in Liberia and ensure that the youth of Liberia are better prepared to succeed academically, enter the workforce, and become productive citizens. The Ministry of Education and ETM have agreed to the following terms and conditions:

4. Obligations of ETM

ETM's model of support constitutes a multi-year, holistic school development approach that will address multiple areas of intervention.

- a. Infrastructure
- b. Instructional and Learning Supports
- c. Staff capacity building
- d. Parent/Community engagement

Along these lines ETM is committed to implementing the following activities (in phases) to improve literacy and the conditions for teaching and learning at Newport Jr. High School:

- 4.1 Infrastructure (Physical Environment Support)
 - Renovate the school library
 - Create a computer lab
 - Create a science/learning lab
 - Provide electricity to the school
 - Provide appropriate sanitation facilities



- Conduct an assessment to determine the feasibility of expanding the school to a senior high school
- 4.2 Academic Enrichment and Learning Supports (Educational Materials, Technological Support, Academic Enrichment)
 - Provide supplemental instructional materials that are aligned with the curriculum
 - Provide teachers with supplies and resources to promote effective teaching
 - Integrate ICT into core content areas
 - Implement data-driven processes including conducting diagnostic and ongoing assessment of student learning to inform instruction and track learning gains
- 4.3 Staff Professional Development (Teaching Skills and Development)
 - Provide teacher training in identified areas of need
- 4.4 Family/Community Engagement
 - Establish PTA (if one does not already exist)
 - Hold family/community engagement activities at the school
- 4.5 Monitor and evaluate all ETM activities at the school, to assess impact on student learning and support continuous quality improvement
- 4.6 Provide quarterly reports to the Ministry of Education, that describe progress, challenges, and planned activities
- 4.7 Participate in periodic update meetings with the Ministry of Education to discuss progress and findings of the MOE monitoring team

5. Obligations of the Ministry of Education

- 5.1 The adopted school will remain under government control and the government will continue to provide funds for regular teacher and administrator salaries, school maintenance and repair, and any other provisions that they would normally allocate for any Liberian public school.
- 5.2 Facilitate the relationship between ETM and Matilda Newport Junior High School
- 5.3 Monitor implementation of the partnership and the activities implemented by ETM at Matilda Newport Junior High School.
- 5.4 Provide ETM with a copy of the updated national curriculum.
- 5.5 Provide ETM with national and school data related to national exams, attendance rates and other indicators that will aid their efforts to support the school and track progress.
- 5.6 Work with the appropriate entities to ensure that ETM receives tax incentives and duty-free privileges.

6. Amendments

6.1 The terms of this MOU may be modified at any time, with the mutual written consent of the parties, and signed by a duly authorized representative of each party. Amendments will come into effect on the date mutually determined by the parties.


7. Additional Terms of Agreement

- 7.1 This MOU will come into effect upon the date of signature by all parties. It will remain in effect for a period of three (3) years. At the end of the given period, parties should have the option to extend the MOU in writing based on mutual agreement.
- 7.2 All proposed activities of ETM, under this MOU, are contingent on the availability of funds.
- 7.3 In the event of a disagreement, dispute or conflict pertaining to any provision of this MOU, or interpretation thereof, each party shall make maximum efforts to resolve it through constructive dialogue and consultation in a spirit of collaboration. However, either party may terminate this MOU without further obligations to the other party by providing the other party 60 days written notice.
