## State News Updates

April 13, 2020

- **Governor Cuomo held a joint conference call at 2 PM with the governors of Connecticut, Pennsylvania, Delaware, Rhode Island, and New Jersey to discuss reopening the regional economy**
  - Each state will name a public health official, an economic development official, and the chief of staff of each governor to form a working group that will start work immediately on designing a reopening plan.
  - The plan is intended to be a “fully integrated regional framework to gradually lift the states’ stay at home orders while minimizing the risk of increased spread of the virus.”
- **Governor Cuomo held a press conference at 11:30 AM and announced the following:**
  - Three-day rolling average for new hospitalizations, ICU admissions, and intubations all continue a downward trend.
  - Total deaths are now 10,056.
  - The Governor believes the density in New York is the reason for the high hospitalization and death rates.
  - Reopening the economy and society is a delicate balance that has never been done before. Steps will include:
    - Ease isolation, increase economic activity, recalibrate “essential worker” economy, apply more testing and precautions, do not increase infection rate.
  - Next steps:
    - Reopening Plan: designed by experts, not politicians: public health and economic experts.
    - Regional Design: larger geographic region the better.
    - Coordinated Design: economic, transportation, schools, etc.
    - Need federal support: smart legislation that attends to the need.
    - Testing will be key.
    - Precautions: masks, gloves, temperature taking are also key.
  - This Reopening Plan will be discussed with other Governors publicly at 2 PM.
- **Governor Cuomo issued Executive Order 202.16. Highlights include:**
  - Requiring essential businesses to provide face coverings for employees at no cost to the employee.
  - Postponing political party caucuses scheduled or required to take place in April or May 2020 until June 1, 2020 unless they are able to be held remotely.
  - Permitting more individuals to perform Coronavirus testing as long as they meet federal requirements for testing personnel appropriate to the device authorized by the FDA or New York State Department of Health.
  - Ensuring no landlord tenant relationship when an individual or entity, including hotels, provide temporary housing for assisting in the response to COVID-19.
