#### 689.. Apologies for Absence.

An apology was received from Cllr. Turner. Cllr. Abbott apologised for his late attendance due to an overrunning meeting at BDC.

#### 691.. Public Forum.

No matters were brought to the attention of Members.

## 692.. Discussion and Agreement of the proposed budget items for year 2013/2014.

The Clerk had distributed to each Member copies of his budget estimate for 31<sup>st</sup> March 2013 and for year 2013/2014.

Proposed by Cllr. Bills, seconded by Cllr. Prime and unanimously agreed that the following Budget figures, as presented by the Clerk/RFO be agreed for the year 2013/2014:

- i.. Parks & Open Spaces... £5570.00
- ii.. Administration... £7830.00
- iii.. Payments made under Section 137... £105.00
- iv.. Capital Projects... £7000.00

The Clerk agreed to investigate the level of cash balances appropriate for this Parish Council and report back.

#### 693.. Requirements under the Audit Regulations.

i. <u>Appointment of Responsible Financial Officer (RFO).</u>

Proposed by Cllr. Wright, seconded by Cllr. Prime and unanimously agreed that the Parish Clerk continue as the Responsible Financial Officer for the year 2013/2014.

ii. Appointment of Internal Auditor.

Proposed by Cllr. Prime, seconded by Cllr. Brailey and unanimously agreed that Mrs. Ann Clarke be reappointed Internal Auditor for the year 2013/2014 with an agreed fee of £60.00.

### 694.. To set the Precept for the year 2013/2014.

Taking the budget figures at item 692 above, the proposed budget for 2013/2014 is £13505.00, excluding £7000.00 from reserve funds for capital expenditure. Less the estimated overall budget saving for 2012/2013 of £1338.00 and BDC's PSG figure of £1737.00 the estimated budget expenditure for 2013/2014, therefore, is £10430.00

Proposed by Cllr. Wright, seconded by Cllr. Brailey and unanimously agreed that, subject to any Government restrictions, a precept amount of £9776.00 be levied for the year 2013/2014.

This gives an estimated Band D equivalent Council Tax of £33.67.
