PRODUCT CHARACTERISTICS:

NATURAL SOLUTION

APILIFE VAR®, is based on **4 ACTIVE INGREDIENTS** (Thymol, Eucalyptus Oil, Levomenthol and Camphor). **APILIFE VAR®** is the organic solution for the treatment and prophylaxis in the fight against varroosis in bees (Varroa Destructor).

How it works: almost certainly, they act directly on the mites through inhalation and contact. This results in the mites coming of the bees.

NO DRUG RESISTANCE

No drug resistance to **APILIFE VAR®** has been recorded in spite of chemical synthesis products (Pyrethroids, Organophosphorus, Amidines and others) which show efficacy levels more and more lower.

USE SAFETY

All components of **APILIFE VAR®** are totally safe for the consumer, bees and all the products of the beehives; these molecules are in fact included in the Table 1 of the EU Regulation No. 37/2010 which contains a list of allowed substances; such list shows

that each active principle of **APILIFE VAR®** is not subject to a maximum residue limit (MRL) in foods of animal origin and therefore also in honey. Therefore the use of **APILIFE VAR®** excludes any toxicological problem of residues in the honey and other products of the beehive.

ORGANIC BEE-KEEPING

Thanks to its natural and safe components, **APILIFE VAR®** is certified, without any limitations, by the Regulations governing ORGANIC BEEKEEPING for the fight against Varroosis (Reg. 2092/91/EEC of 24th June 1991 and following modifications).

USE PERIOD:

The ideal use period varies according to the climate of the different countries; anyway we recommend the use during the warm season (late summer), immediately after the honey harvest.

Ideal temperature of use: 20°C - 25°C (68°F - 77°F). Insufficient efficacy can be expected if the average outside temperature is lower than 15°C.

The special mixture allows a proper

evaporation of the active ingredients inside the beehive even when the external temperature is lower than the seasonal average.

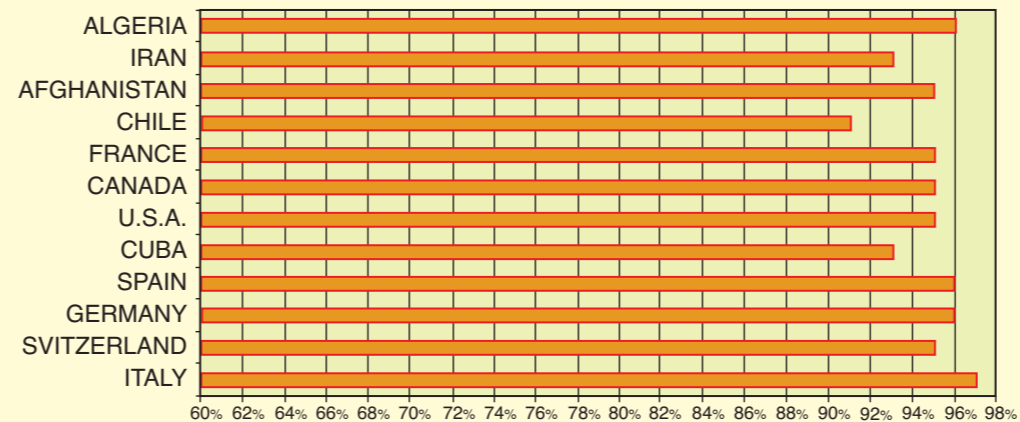
ADVICE FOR USE:

- All colonies in the same apiary should be treated simultaneously to avoid robbery.
- Avoid the risk of robbery creating strong families and do not treat if robbery is in course.
- Treat by introducing the product into the beehive either early in the morning or late in the afternoon towards sunset.
- Treatment at temperatures above 30°C leads to increased stress and disturbance of the hive.
- Do not use during the honey flow but after the relative honey harvest.
- Do the treatments without supers.
- Do not place the product in the center of the beehive or near the brood.
- Do not exceed the recommended dosage.
- Do not use simultaneously with other acaricides.
- Handle with care the package.
- No eke is required.
- It is not required a direct contact between the bees and the product in order to get effectiveness.

Experience over many years using the product as well as numerous studies carried out in Italy and internationally prove the high effectiveness of **APILIFE VAR®** showing an average Varroa mite drop of higher than 90%.

EASY TO USE:

1

Open the bag containing the two strips.

2

Take one of the two strips and break it into 3-4 parts.

3

Open the beehive and set the single pieces of the strip in the corners of the beehive.

4

Close the beehive and let the product work for 7 days.

Repeat the treatment for 4 times with the other strips.
