<u>Awards</u>

Awards will be presented to fourth through first place recipients.

<u>Rules</u>

1. All participants competing in point fighting must wear head, hand, and foot

gear. A mouth guard is also required for all point fighting competitors and all boys and men must wear cups.

2. Drawing blood on your opponent will result in disqualification as decided by the head judge and confirmed by the tournament arbitrator.

3. Contact and point fighting rules: No contact to the face, legs, groin, or spine. Light contact is allowed to the protected portion of the head. Should a competitor receive an official warning, a point will be given to their opponent on the first warning. Upon the second official warning the competitor will be disqualified. No time limit in all point fighting divisions. All underbelt matches to 3 points and all black belt divisions to 5 points.

4. All decisions made by the tournament arbitrator are final.
