## State News Updates

April 11, 2020

- **Governor Cuomo held a press conference at 11:30 AM and provided the following information:**
  - Curve is flattening as total hospitalizations is beginning to plateau.
    - Total new hospitalization three-day average is on the downward slope.
  - Total deaths is now 8,627, up from 7,844.
  - The Governor is saying there are no political conspiracies, all projected models had higher numbers that did not take into account the government action to flatten the curve.
  - Immediate actions need to take place:
    - More testing and advanced testing.
    - More preparedness.
    - Federal stimulus bill to help the states.
    - Repeal SALT to help the most affected areas.
  - New York State Court System will engage pro bono lawyers:
    - <https://nysba.org/covidvolunteer>.
  - Reopening is a public health question, and an economic question.
    - The Governor will not separate the two.
    - Before the decisions are made, New York will study information on reopening and a possible second wave of infections.

April 9, 2020

- **Governor Cuomo issued Executive Order 202.15. Highlights include:**
  - Allows pharmacies to conditionally receive drugs and medical supplies from an unlicensed pharmacy, wholesaler, or third-party logistics provider in another state to alleviate shortages.
  - Delays the April 1 requirement that parents must file transportation requests with their school district to obtain transportation for the following school year.
  - Permits funeral directors licensed and in good standing in any state or territory to practice in New York State without penalty related to lack of New York State licensure.
  - Allows an absentee ballot can be granted based on temporary illness and shall include the potential for contraction of COVID-19 virus for any election held on or before June 23, 2020.
  - Allows for electronic application, with no requirement for in-person signature or appearance, to be able to access an absentee ballot for any election held on or before June 23, 2020.
