***The following notes were taken during a question and answer session with Director John Cocca of the Department of Liquor yesterday May 6th. These questions relate to opening your business on Monday May 11th.***

***Director Cocca responded to the following questions:***

- 1) Lag time after meal is over? Is that allowable? Director Cocca is not getting into that; he is not going to enforce occupancy code and use judgement regarding if EO is being followed.
- 2) One person eats, one person doesn't is that okay - yes, that's ok.
- 3) If a bar is complying with distance, offering food, making it available, telling individuals about the approximate time to get service and availability to get food, is that okay? Yes.
- 4) 6 and 7 licensees who do not have a kitchen in the bar, if they have a food truck out front or have 20 Domino Pizzas and sell pizza for a \$1 a slice, is that okay? Director Cocca - yes, licensees have to be responsible for their actions, there are only 11 people available to investigate for the entire state.
- 5) Senator Karen Fann, she said - any food counts, bars that don't have a dining room - chips, popcorn count as food? Definition of food is not determined by DLLC, but County Health writes a report - they may investigate.
- 6) Will there be warnings first? - Director Cocca - probably yes, unless it is really outrageous behavior, they want compliance.
- 7) Same groups that arrive together don't have to have them 6 feet apart? Director has to read the guidance; seems to make sense that if you arrive together that you would sit together at the same table, but don't know how the local police will look at it.
- 8) Speak easy - Air BnB's running bars - DLLC will follow-up, if PD not enforcing; they will be cited? Director Cocca said it would depend on facts, seems like running a bar without a license is different than people being too close to one another.
- 9) NO special event licenses are being issued right now.
- 10) Special event - such as silent auction, will they be able to get a special event license? Director Cocca said he is open to discussing it.
- 11) Temporary extension of premises - Yes, those are still being issued.
- 12) Large venues - Director Cocca believes guidance will be issued by the Governor; believes if venues follow EO, it is okay.
- 13) 12's can still sell to go? - yes, at least through the 15th; VFW's are being left out of order? Not a decision Director Cocca will be making. If someone could raise the idea to the Governor if this gets extended to include VFW and other types of clubs? Director Cocca said that is up to the industry.

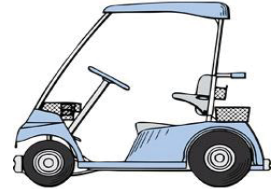
