MUJER NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED MARCH 31, 2012

1. INCORPORATION

Mujer was incorporated February 21, 2003 by letters patent without capital under the Business Corporation Act of Ontario. Mujer is not-for-profti corporation, and accordingly, is exempt from income tax under Section 149(1)(i) of the Income Tax Act.

Mujer provides programs and skills development opportunities to promote the integral development young women within the Latin community. They promote policies which strenthen and sustain personal growth and economic independence.

2. REVENUE RECOGNITION

Revenue from grants is recognized when due under terms of any related contracts. All other revenues are recognized when received.

3. CONTRACTUAL OBLIGATION

The organization leases its premises under an agreement which calls for annual rental payments of \$10,848.00

4. STATUS OF WOMEN

Funds being received on this grant are for the three year period March 2010 to March 2013. Any funds remaining at the end of the grant term are to be returned to the funder.

5. TRILLIUM

Funds being received on this grant are for a one year period December 2011 to December 2012. Any funds remaining at the end of the grant term are to be returned to the funder.
