1. Deposit, Payment of Purchase Price, Fees

Buyer acknowledges and agrees that Buyer will forfeit the deposit and any rights to the Dog if		
(a) Buyer fails to complete the purchase of the Dog for any reason, or		
(b) Buyer fails to pay the balance of the Purchase Price within 14 days of Pick of puppy being chosen. (puppies need to be chosen at/by 6 weeks of age)		
In either event, Breeder shall be free to sell the Dog to another party.		

In the event that the Dog is not available due to sickness, death, or any other circumstance owing to the fault of Breeder, Buyer's deposit will, at Buyer's option, be either (i) refunded, or (ii) transferred to the next litter of puppies.

## 2. Breeder's Representations and Warranties

The Dog is in good health and free of communicable diseases (I.E parvo, Distemper) at the time of this sale. Buyer has 3 days from the delivery date to have the Dog examined by a licensed veterinarian, at Buyer's sole cost. If the Dog fails the examination, Buyer may return the Dog, with a written statement from the veterinarian, for a full refund. Failure by Buyer to have the Dog examined within the 3 day period will nullify this warranty. If Buyer chooses to keep the puppy, no replacement will be given and all medical costs and treatment are sole responsibility of the Buyer. This health guarantee will be null and void.

(e) This Warranty does NOT cover coccidia/ghiardia, Cherry eye, Entropion, Ectropion, Allergies, undescended testicles, loose knees or hips, Stenotic nares, elongated soft pallet, umbilical hernia, dermatitis, demodetic mange, or ear infections.

Breeder will NOT replace a puppy due to heat stroke, abuse/neglect, or improper socialization.

Buyer agrees that they have thoroughly researched the Breed and its grooming/training requirements.

3. Buyer is responsible for all medical costs of their puppy. (No refunds will be given)

This warranty covers only the original Buyer and is not transferable to other parties.

\*\* To ensure that Buyer does not euthanize the Dog or take it to an animal shelter, or sell to a third party - it is required for whatever reason that said dog is to be returned to breeder

Breeder will always and for any reason take the Dog back at any time during the Dog's lifetime.
