<u>Question:</u> When attending meetings for adults at a Conference/Convention, upcoming Sunday School Class, Mid-week Class, Civic/Social Organization, or <u>any</u> Gathering, etc. that emphasizes Christian Morals and Values, what will be the thoughts and actions taken regarding Babies, Toddlers, Children, Teenagers, Youth and their Mothers, Fathers, Family Members of these immigrants in these situations will you CONSIDER, then TAKE ACTION?

Some Facts:

Shameful:

1. What about Babies/children [unknown to parents/families] who have been secretly moved to places far from each other(perhaps even closer to you than you might think!).

What about Non-talking Babies/Non-English-speaking children in U.S. Courts [with/without mothers/fathers] expected to defend [ultimately incriminating themselves to U.S. authorities?

- 2. What about mothers, fathers, siblings, family members being sent back to the homelands they fled a) to try and protect themselves; b) to give their children a better life than what they had endured, as violence, sexual molestation, sexual abuse, etc.; being forced to join gangs or to commit acts to which they disagreed because of illegalities; c) "no freedom," etc., [CONSIDER WHAT WILL HAPPEN WHEN THEY ARE RETURNED TO THEIR HOMELANDS. YOU KNOW WHAT? YOU WILL NEVER EVEN BEGIN TO IMAGINE WHAT WILL HAPPEN TO THEM WHEN THEY RETURN. THERE WILL BE A "TRIPLING DOWN" OF WHAT WILL HAPPEN TO ANYONE/EVERYONE WHO FLED: TORTURE, MAIMING, FORCIBLE ACTS; MURDERED/KILLED, etc.. Imagine the continued traumatization, the mental anguish at being separated from their loved ones—whether within the U.S. or outside of the U.S.. Imagine not being able to communicate with your baby/child on even a daily basis? Imagine your child not being old enough to talk, not being able to communicate with someone who does not understand his/her language.].
- 3. What about mothers/fathers/families in court, with their legal rights, being "grilled" [yet, not believed] as to why they came to the U.S. (*THINK*: If conditions were better in their homelands, would there be a need to enter the U.S.? Consider what they endured to get here: abandonment, trafficking, sexual abuse, mental abuse, no financial means to get here. What was their food? What did they drink? What happened to those with physical and/or mental disabilities? to those needing medical attention? to those falling prey to all kinds of predators people, animals, reptiles, etc.? What about weather conditions? What about the bodies of waters that had to be navigated?

Once in U.S., imagine the deplorable/unbearable living conditions: Inappropriate clothing, inadequate bedding, freezing temperatures. What about their "new" accommodations: no privacy, not privy to sunlight nor warmth, shut up in closed quarters without mattresses; quartered in "boxes," etc.?

4. What about appearing in U.S. Court Systems – contending with persons who do not understand them (language barriers) without persons who would/could adequately represent them (attorneys/lawyers, etc.)

What You can Do:

- 1. Contact officials/agencies/persons in your state/local communities who will provide help:
- 2. Work with legalized community efforts (in volunteer roles, (hopefully pro-bono, including
 - a) Most importantly: Language speaking persons for communication purposes)
- b) News Media, who continuously keep us up-to-date with what is happening. If it weren't for them, we would not know of this cruelty that exists in our U.S.A.
- c) Mental/Medical Attention: Many babies, children, parents, and families considering conditions in their homeland have already suffered/endured from long periods of times severe trauma from violence, rape, "unspoken encounters," etc.

[Medical Professionals to include psychiatrists, psychologists, certified mental health therapists, peer specialists, other kinds of therapists; various kinds of physicians, nurses, assistants; various kinds of therapists: physical, occupational, etc. Medial physicians who can provide appropriate prescriptions, medications, etc. for any child/person needing such.]

Others related to this category include qualified persons who can give Pastoral Care, including the knowing and realization of Jesus Christ:

- a) John 3:16
- b) Knowing/Realizing that God's Grace, Love, Mercy **will permeate** in their Bodies, Souls, and Spirits even in these severe times.
- c) Knowing/Realizing there is **HOPE** for each of them.
- d) Knowing/Realizing there are those of Us who are "with them" through their turmoil provided through 1) our everyday thoughts, prayers; fastings; 2) through items we can send; 3) through money we send to help them re-unite to their loved ones; 4) through helping them get properly settled in whatever place they go; through providing the best of food, shelter, clothing; medical attention [mental, physical. Financial, etc.]
- e) Evidencing the LOVE of JESUS CHRIST.
- f) Heeding II Chronicles 7:14.
- g) Continuing to Pray and to Fast (on an individual basis).
- h) Participating in CORPORATE DAYS OF PRAYER AND FASTING. [See page 4.]

- 3) Locate Attorneys/Lawyers, etc. to help parents retrieve their babies, children
- 4) Locate Local Supporting Politicians, who CAN AND WILL GIVE EXACTING, APPROPRIATE DIRECTIONS TO IMMEDIATELY ALLEVIATE THIS ATROCIOUS PROBLEM.
- 5) LOCATE EDUCATORS, PARTICULARLY THOSE SPEAKING THE LANGUAGE OF THE CHILDREN

 REASONS: 1) TO HELP CHILDREN, TEENS, YOUTH CONTINUE THEIR EDUCATIONAL

 PROCESS.
 - 2) TO TEACH SKILLS, HELPING THEM FIND WORK WHEN THEY GET FINALLY GET SETTLED

SUGGESTIONS OF "LITTLE THINGS YOU CAN DO OR PROVIDE":

NOTE: FOLLOW LEGAL GUIDELINES FOR ANYTHING YOU MIGHT DO OR SAY.

- A) KEEP YOURSELF UPDATED: READ/LISTEN TO CURRENT, ACCURATE NEWS -
- B) Provide schooling; proper living conditions; proper foods to accommodate special diets needed; diapers; clothing;, shoes, food, toiletries, personal items for females, etc..
- C) When a <u>"holding facility"</u> is located near you, volunteer to help: changing/feeding babies and toddlers; caring for all children (talking/reading to them); laundering their clothing; visiting them (interacting [talking, reading, playing games, doing physical [including walking and sports]/educational activities, exercising
- D) Consider/adapt to appropriate/legal things done in localities for persons involved in natural disasters [severe storms, fires tornadoes/hurricanes, floods, volcano eruptions, etc.] What actions are taken by first responders, policemen, firemen, medical professionals, citizens, Red Cross and similar groups, churches, civic groups, other persons.

E) Consider, then Participate in a "Corporate Prayer and Fast Day for the Reunion of Children to their Parents/Families" [minimum of 1 hour per day each Wednesday until all children are reunited with their parents/families (unless/until "head authorities dictate otherwise)].

General Procedures (for more complete details, read "A Corporate Day of Prayer and Fasting")

- 1) Take time to ready yourself for this endeavor:
- *Is this for you to do? Pray and Fast for your answer. If your answer is "Yes:"
- 1) Get yourself ready: Read, Concentrate, Meditate on your task-at-hand.
- 2) Throughout this time, Pray for GOD's Guidance, Wisdom, and Anointing.
- 3) Often throughout the day, Read and Concentrate on appropriate Scriptures from the <u>Holy</u> Bible.
- 4) Continue your involvement in Bible Studies, other Bible Readings
 - 5) Concentrate your efforts on the well-being in each and every aspect of <u>each</u> of the unborn babies, infants, toddlers, children, teenagers, young people, as well as the parents, grandparents, siblings, family members, neighbors, etc. of all immigrants.
- 6) Keep yourself refreshed regarding the contents of these 2 documents relative to this topic.

 Pray for each condition of each person known and unknown. (GOD knows each.)
- 6) Even if not fasting, keep yourself in an "atmosphere and attitude of Praying and Fasting".
 REMEMBER: The positive answer to our requests depends upon each of us, as "Prayer Intercessors" for our Sisters and Brothers in need.
 - 2) Begin Praying on Wednesday, August 1. Begin Praying and Fasting on Wednesday, August 8.

 - 3) Why can't all children and the entirety of each/all facilities be visible, be visibly accessed, be visibly evaluated?
 - 4) Why can't cameras of authorized persons, including the Media be allowed?
 - 5) Why can't mothers, fathers, family members know where their children are?
 - 6) How can children be joined to their mothers, fathers, siblings, family members when there is no proper paperwork nor proper means of identifying parents to their children?
