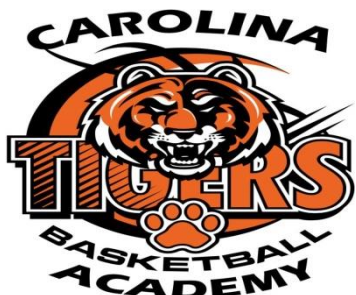

## **REGISTRATION AND ADMISSION**

### **REGISTRATION PROCEDURES**

1. Before enrollment of any student, there will be a two-part screening process. Parents are first interviewed by the director and given a tour of the facilities. This pre-arranged visit usually takes 15-30 minutes.
2. An application of enrollment is given to the parent for completion.
3. After receipt of enrollment application, another appointment is scheduled with the Director for orientation to the school. This visit usually lasts 30-40 minutes. The orientation will involve discussion and completion of the following items:
  - Policies and Procedures in the Parent/Student Handbook
  - Completion and signing of all required documents.
4. Orientation is required before starting school.

### **ADMISSION PROCEDURES**

1. Parent(s)/Legal Guardian must:
  - Read the Handbook thoroughly.
  - Complete all forms in the Admission packet and return to the school office for processing.
2. Provide the following documents with Admission Application:
  - Current medical records/Immunization records/School records.
3. If your child is accepted for admission, you will be notified.
4. Parents are required to attend the Parent Orientation when scheduled at the beginning of the school year.
5. All tuition and fees must be paid prior to the start of the semester. First month's tuition is due August 1st.

### **Tuition and Fees for Grades 9-13**

Application/Registration Fee (Non-refundable) \$275.00

Diagnostic screening tests are \$250.00. The amount is non-refundable for Math and Reading, as well as any National Standardized Testing. Students who need help in Reading and Phonics must purchase a workbook for \$45.00. (May be waived based on transcript evaluations)

Upon acceptance, the following fees are required before enrollment.

#### **Yearly Tuition**

Tuition is \$18,000 yearly or \$1,800 monthly for all domestic students. International Student yearly tuition is \$25,000 yearly or \$2,500.00 The first payment begins at the time of enrollment and the last payment May 1, 2019 Payments are made over a 10-month schedule if the student attends no later than August 15, 2018. Students who enroll after August 15, 2018 tuition will be scheduled for the number of months reminding.

**Deposit (non-refundable) required for all enrolled students. The initial monthly fee is required and the current month will become prorated. Each additional month will be subsequently charged after enrollment date.**

**Non-refundable deposit** fee of \$3,500.00 is required at the time of student registration.

#### **Tuition**

Based upon the date of enrollment, tuition is prorated to reflect your start after the first of the month. All tuition payments are due by the first of the month. Any late tuition payments will be subject to a late charge of \$50.00. Tuition is late after the fifth of the month. **Tuition WILL NOT be accepted as partial payments, the amount of the tuition is to be paid in full at the beginning of each month.**

\_\_\_\_\_ (Parent(s) Signature) **If tuition and late fees are not paid by the 15th of the month, parents are asked not to bring their child to school until the amount is paid in full, or arrangements made with the Administrator.**

Students who enrolled with only two or three month left before school year ends will be assessed a minimum of 5 months' tuitions, students are able to complete his/her credits with within the remaining CBA school year.

*Tuition* paid to Carolina Basketball Academy is non-refundable after the child is enrolled. Students enrolled for the entire school year and such portion that has been paid will remain after the date of entrance. All returned checks will be charged a non-sufficient fee of \$35.00.

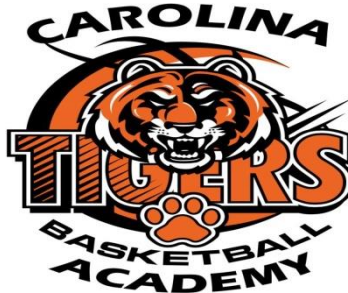

## **PHILOSOPHY**

To establish an educational environment that is conducive to learning. To help establish the fundamentals of education that would provide students with the tools necessary to perform in a world of constant change. To help shape and mold young minds to become leaders in our society where a strong educational foundation is imperative. We understand, if given a chance, anyone can learn to be successful and learn to be responsible people.

Education dictates that goals be established to develop the whole child; academically, socially, emotionally, physically, and spiritually. Carolina Basketball Academy's stated goals foster the development by approaching education from an independent point of view.

- Develop mastery of core academic subjects, fundamental processes in effective communication, clear writing, reading, math, and effective listening skills.

- Acquire the skills necessary to promote a lifestyle of physical fitness, good health, wise use and proper care of the body.

### ***Mission Statement***

The mission of Carolina Basketball Academy is to give every student the tools necessary to be successful in life. We also believe that if given the chance, each student can learn and achieve his or her goals academically, socially, physically, emotionally, and spiritually. We are committed to give every child a sound and solid foundation in the skills necessary to function in society. We want to help every student to believe, to achieve, and to have faith that they, too, can be successful in life. To enable them to realize their gifts and talents and that *nothing is impossible when God comes first*.

### **ATTENDANCE**

#### **Class Session**

School hours are 8:00 a.m. to 2:30 p.m. Classes begin at 8:00 a.m. for Grades 8-13 and end at 2:05 p.m. Students are to be picked up by 2:30 p.m. After 2:30 p.m., arrangements should be made for your child. (See “Before and After School Care”).

#### **Absences and Tardiness**

Regular attendance is essential to successful class work. Students who are absent must bring a written excuse note from their parent or guardian when returning to school. According to school law, the only legal reasons for school absences are verified illness of the student, bereavements, or verified doctor appointments. Some absences, which are not normally permitted by school law, are sometimes allowable providing they are known and approved by C.B.A. in advance. All class work and homework that is missed during their absence will be made-up by the student. Unexcused absences may result in the student being expelled or failing their grade. State law allows students to miss up to five (5) days per semester per class. Students with more than five (5) absences per semester automatically fail that semester unless hours are made up. Class hours can be recovered via Saturday school (scheduled as needed) at a charge of \$25.00 per hour, usually from 9:00 a.m. to 1:00 p.m. Tuition continues in all grades during any absence.

**NOTE:** The five (5) absent limits applies to all absences including illness, accidents, trips, etc., whether excused or unexcused. While all absences count toward the five (5) per semester limit, documenting that an absence is excused allows the student to make up tests, quizzes, and class work without penalty, having one (1) day for each day absent. (This policy is not intended to be abused by a student not turning in 5th period work, for example, because he/she had a dental appointment first period). Skipping/unexcused absences, on the other hand, make all homework, quizzes and tests taken that day count as a zero (0) for 50% off, at the teacher’s discretion. Furthermore, any unexcused absence/class cut will result in work detail. One (1) cut will result in a warning. A second cut will result in detention. A third cut will result in suspension.



### Tardiness

Any student is tardy if he/she is not in class on time. Students in K-3 are tardy after 8:30 a.m. and students in grades 4-12 are considered tardy after 8:00 a.m. Three (3) unexcused tardies equal one (1) day absent. Continued tardiness can result in dismissal from school. Any time a student is tardy, he/she must come by the school office for an admission slip to be admitted to class. No exceptions! A note from a parent or guardian stating the reason for absence or tardiness must be given to the office within two (2) days of the occurrence.

## **DRESS CODE**

Time spent on dress code detracts from learning. Students are expected to dress respectfully. No tummy or cleavage showing, pants are on hips, and no torn clothing. Students will be dressed in uniforms at all times. If students do not adhere to dress codes, parents will be asked to pick up their child to change clothing. Students who are given three notices to change their attire of clothing to what is required will face suspension and possibly exclusion from Carolina Basketball Academy.

For boys, pants must be worn with a belt and a button down/polo shirt. Shirts must be tucked in pants at all times. No exceptions! Boys are to wear their hair neatly groomed.

Please read all information included in your packet as we have a separate sheet that gives more information.

## **DISCIPLINE**

In order to meet these guidelines for objectives, students must understand our rules and the consequences when those rules are not followed. Students also need to develop relationships with teachers and classmates based on mutual respect.

### **Removal From Class**

The classroom environment must be one in which maximum learning can take place. Students must have respect for education so that they do not disrupt class or interfere in any way with the learning process. If a student is disruptive in class, the student must be removed from class. Disrespect, rudeness, excess talking, etc., will result in class time lost in ¼ hour increments and can result in other consequences as deemed appropriate by the staff including time after school and work detail. Students who persist in negativity or are guilty of serious infractions face suspension (time counted as unexcused absences) and/or expulsion.

### **Off-Limit Areas**

Students are not to congregate around parked cars during school hours. Students may not sit in parked cars at any time during the school day. The administrative office is off limits. Failure to comply will result in work detail, parent conference, or suspension.

## ACADEMICS

### Homework

Believing that homework is an integral part of the school, each teacher gives homework to aid the student to advance his/her studies. Therefore, students are required to complete their homework assignments on time. We request the parent's full cooperation in seeing that the assignments are completed. Repeated delinquent homework could result in a student's expulsion.

### Books and Supplies

All books and school supplies must be purchased by the parents. Students must bring books and supplies at school every day.

### Before and After School Care

The school will not be responsible for students before 7:00 a.m. or after 2:30 p.m. Any student arriving before 7:00 a.m. must wait with the parents until 7:00 a.m. Students remaining on the school premises after 2:30 p.m. are required to go to Extended Session. (Applies to all non-boarding school students)

Our after school care program for Carolina Basketball Academy students start at 3:30 p.m. until 8:00 p.m. at a rate of \$10.00 per hour or a flat rate of \$75.00 per week. Students enrolled in Carolina Basketball Academy; however, will be charged only \$65.00 per week. All fees are payable weekly, in advance. Each student not picked up by 8:00 p.m. will be charged a fee of \$1.00 per minute, payable when you pick up your child. Before school care will be arranged on an individual basis. (Applies to all non-boarding school students)

# CONDUCT

## CONDUCT AND DISCIPLINE

### *ADD or ADHD Students*

We reserve the right that a student be tested for ADD/ADHD at the expense of the parent. If a student is diagnosed as being ADD or SDHD, and the doctor has prescribed some form of medication make sure that your child take it before coming to school. We do not administer drugs to children.

### *Student Conduct*

The classroom is a place of learning for those attending. Due to this fact, there are several regulations placed upon the students.

The teacher has full control of the classroom. Each student is expected to show respect to the teacher. No student will leave his/her seat without permission from the teacher. In all classes, students are not permitted to talk unless it involved class discussion and interaction with the teacher.

### *Unacceptable Conduct*

- No student is to bring rock music, tapes, magazines, offensive books, or any other item, which the administration considers contrary to our standard set forth for our students.
- No student may use tobacco on the premises
- No student may use alcohol or narcotics on the premises
- No student may bring a weapon onto campus
- No student may use profanity
- No student may be involved in sexual misconduct
- No student may use cell phones at school. If there is an emergency, please contact the administration.

## ENROLLMENT

Students who enroll with Carolina Basketball Academy (hereafter referred to as C.B.A.) are expected to maintain a positive attitude toward learning. Upon entry, each student is required to take an entrance exam test in Math and Reading to assist in proper placement.

Due to limited resource and facilities, C.B.A. is unable to meet the needs that are required for certain behavioral problems and learning disabilities. (Assessments may be required in some cases).

### Telephone/Lost & Found/Early Dismissal

#### TELEPHONE

Please do not ask to use the telephone during school hours unless absolutely necessary. Interruptions such as phone calls are very disruptive to a class session. Students and teachers are not permitted to use the school phone during class time except in a case of an emergency. **CELLULAR PHONES ARE PROHIBITED TO STUDENTS DURING SCHOOL HOURS. IF THERE IS AN ABSOLUTE NEED TO USE A TELEPHONE, PLEASE REPORT TO THE OFFICE.** If caught using the cell phone on campus, the phone will be confiscated and held a school until a parent comes to claim it. *(Telephone Usage takes away from your child's learning ability and instructional time.)*

#### LOST AND FOUND

Lost and found articles are taken to the school office. Items that remain unclaimed after the one month will be disposed of.

#### EARLY DISMISSAL POLICY

1. Students who wish to have an early dismissal must bring a parent/guardian note to the office before 8:00 a.m. on the day of the early dismissal. The note must list the phone number where the parent/guardian can be contacted. If the parent/guardian cannot be contacted, the early dismissal will be denied.
2. Students with early dismissals must sign out in the office before leaving school. ***Failure to do so will considered cutting class.***
3. **In an emergency situation**, parents/guardians must call or report to the office to arrange an Early Dismissal.
4. No Early Dismissal will be granted on exam days with prior approval from the Director.

*Note:* Cutting class is defined as any unexcused absence from a class. For example, if a student leaves school without signing out or if a student arrives to school after first period of the day without signing in, the student is guilty of cutting class or classes missed. Consequences are discussed in the attendance section.

## LUNCH

Grades 9-13 boarding students will receive free lunch daily. Students may bring their own lunch if they wish to decline their lunch from school.

## **CONTRACT OF TERMS AND CONDITIONS**

**Withdrawal of Student:** In order to officially withdraw a student from Carolina Basketball Academy (“The School”) the parent(s) must submit a signed letter indicating the withdrawal date and reason to the Admission Office. No withdrawal will be official or complete until the Admission Office receives and approves the letter.

**Rules and Regulations:** I/We agree to accept the rules, regulations, policies, resolutions, and guidelines (hereinafter called “School Rules”) adopted by The School and set forth in its latest publications or otherwise communicated to me. I/We also understand that, except for the Arbitration Agreement, any and all School Rules can be changed at any time by The School. The School retains the right to add, change or delete policies or other school conditions at any time (except the Arbitration Agreement, which may not be changed altered, revised, or modified without a writing signed by the Head of School). I/We understand that the student’s, parent’s, or guardian’s disregard of the School Rules (whether on or off campus) may be deemed sufficient cause for dismissal.

**Timely Tuition/Student Records:** I/We also understand that all accounts must be paid before records and transcripts can be released or transferred to other schools and colleges and that our student will not be permitted to continue to attend classes unless tuition and fees are paid by stated deadlines (or until I/we make other written arrangements acceptable to the School). I/We also understand that the School shall have the right to take such legal action as it may deem appropriate to collect all amounts which are not paid when due. In the event the School takes legal action to enforce the terms of this Contract, I/we shall be responsible for all costs, including reasonable attorney’s fees and costs (whether incurred before, during, or after the filing of a recovery action.)

**Medical Care/Treatment:** It is my/our specific intention that a representative of the School may designate authority for emergency medical care in a licensed hospital or other health care facility while my/our child is enrolled at The School. I/We hereby release the School (and its owners, trustees, directors, officers, managers, employees, agents, and parties affiliated with it) from any and all liability resulting from or pertaining to the seeking of medical care.

**Consent to On Site Medical Care, Including Student Counseling:** I/We hereby authorizes the School to supply medical care as needed for Student (including administration of allergy medications, Epi-Pens, etc. according to my child’s prescription from a licensed practitioner) or other minor medical care as determined to be appropriate by the School nurse. I/We also authorize the School’s student guidance counselor to meet and counsel with my/our child regarding emotional, social, or family circumstances. I/We hereby release and hold the School harmless from any liability which might arise from the provision of such medical care or counseling services.

**Authorization for Photos/Academic Records/Release:** I/We authorize the use of my/our child's image, information, voice and photographs in School publications, including, but not limited to, training or promotional videos, brochures, and on the School's website. I/We also authorize the School to send academic records and confidential recommendations (and updates or corrections to reflect changed circumstances) to post-secondary schools and I/we will not seek access to confidential recommendations and evaluation materials. I/We hereby release the School (and its owners, trustees, directors, officers, managers, employees, agents, and parties affiliated with it) from any and all liability resulting from or pertaining to the furnishing or updating of recommendations and records.

**Directory Information:** I/We authorize the School to place family information, including name(s) home address, and e-mail addresses, and telephone numbers of parent, student, and other children in attendance at the School, in a directory of students to be distributed to School families. This directory may be available in "hard copy" or online.

**Brochures and Other Materials:** The School continually strives to update the accuracy of all written materials, including, but not limited to, promotional information, catalogs, brochures, handbooks, and advertising. In an effort to do so, however, information included in the materials, (including class sizes, student-to teacher ratios, school accreditation, teacher qualification, specialization, and length of service, etc.) may change as programs grow and as staff changes. Prior to relying on any written materials in making your decision to enroll a student in the School, please verify the accuracy of information with the Admission Office. Please also understand that even if information was accurate at the time that you enrolled your student, the information may change prior to commencement of classes or during attendance at the School. Please also note that only the Head of School (or his/her designee) has the authority to make commitments regarding the nature of the program, specific arrangements for your student, or other changes from the School's regular curriculum.

**Cooperative Relationship with Family:** I/We understand and agree that a positive and constructive working relationship between the School and parent(s) is essential to the fulfillment of the School's educational purpose and that the School reserves the right not to extend the privilege of enrollment or re-enrollment to a student if the School reasonably concludes that the actions of parent make such a positive and constructive relationship impossible or otherwise seriously interferes with the School's accomplishment of its educational purpose. Moreover, I/we understand that the School reserves the right to expel my/our student at any time if, in the judgment of the Head of School, conduct of anyone directly associated with the student, including but not limited to the student's parent/guardian, in or out of the School, is not in keeping with the School's accepted standards or principles. There will be no refund of tuition where such enforced withdrawal occurs and any unpaid balance is payable in full according to the payment schedule in this Contract. If, for any reason, it is in the best interest of the School, the School also reserves the right to withdraw an offer of enrollment or re-enrollment at any time, and to nullify an executed Enrollment Contract.

**Reimbursement for Domestic Legal Issues:** I/We understand and agree that the School's primary purpose is to provide educational opportunities to the students within its institution. I/We also understand that it is disruptive to the School for a parent to involve the School (or any of its employees) in domestic legal disputes between the parents and that the School often must pay for

legal fees and costs associated with such issues. Therefore, I/We agree to promptly reimburse the School for all expenditures incurred by the School as a result of my/our domestic legal disputes, including, but not limited to: parental disagreements about my child's education or placement; divorce proceedings; custody proceedings; and/or modifications of custody proceedings. Costs incurred may involve reasonable attorney's fees/costs to prepare for and/or attend depositions, trials, or hearings; communication with me/us or my/our counsel, guardian's ad litem or attorneys ad litem; to respond to subpoenas; draft letters or motions; and to perform research. Costs include the cost of copying documents, providing records, engaging substitute teachers or temporary employees, computerized research, and travel expense. I/We agree to reimburse the School for such fees/costs within thirty (30) days of the School billing me/us for such expenses. We agree that any dispute between the parents regarding which parent may owe which portion of the bill should be resolved between the parents so that the bills for reimbursement to the School can be paid on a timely basis. I/We understand that my/our failure to pay such fees/costs promptly will result in dismissal of the family from the School and possible legal implications to the parents.

**Arbitration of Claims:** I/We understand that the School has a system of alternative dispute resolution, which involves binding arbitration to resolve all disputes, which may arise out of the relationship between students, parents, and the School. Because of mutual benefits (such as reduced expense and increased efficiency) which private binding arbitration can provide both the School and myself/ourselves. I/We agree that any claim, dispute, and/or controversy (including, but not limited to, any contract claims, any statutory claims, including claims of discrimination and harassment under North Carolina or federal law, any claims under local, state, or federal ordinances, laws, or regulations, and any common law claims) which would otherwise require or allow resort to any court or other governmental dispute resolution forum between myself/ourselves and The School (or its owners, trustees, directors, officers, managers, employees, agents, and parties affiliated with it) arising from, related to, or having any relationship or connection whatsoever with my/our relationship as a student or parent or other association with The School, whether based on tort, contract, statutory, or equitable law, or otherwise, shall be submitted to and determined exclusively by binding arbitration under the Federal Arbitration Act. However, in addition to requirements imposed by law, any arbitrator herein shall be a retired North Carolina Circuit Court Judge and shall be subject to disqualification on the same grounds as would apply to a judge of such court. Moreover, the following rules shall apply and be observed in the same way that such rules are applied in the United States District Courts: all rules of pleading, discovery, and evidence (including the right to resolution of the dispute by means of motions for summary judgment and judgment on pleadings). Resolution of the dispute shall be based solely upon the law governing the claims and defenses pleaded, and the arbitrator may not invoke any basis (including but not limited to, notions of "just cause") other than such controlling law. The arbitrator shall have the immunity of a judicial officer from civil liability when acting in the capacity of an arbitrator, which immunity supplements any other existing immunity. Likewise, all communications during or in connection with the arbitration proceedings are privileged. As reasonably required to allow full use and benefit of this agreement, the arbitrator shall extend the times set for the giving of notices and setting of hearings. Awards shall include the arbitrator's written reasoned opinion and, be subject to affirmation, modification, correction, or vacation in accordance with applicable law. Should any term or provision, or portion thereof, be declared void or unenforceable it shall be severed and the remainder of this agreement shall be enforceable.



**I/WE UNDERSTAND THAT THIS BINDING ARBITRATION PROVISION REQUIRES BOTH I/WE AND THE SCHOOL TO GIVE UP OUR RIGHTS TO TRIAL BY JURY.**

Jurisdiction and Law: This Contract shall be governed under the laws of the State of North Carolina. The venue of any arbitration hereunder shall lie exclusively in Charlotte-Mecklenburg County, North Carolina, and the parties hereto consent to personal jurisdiction.

I/WE HEREBY ACKNOWLEDGE THAT I/WE HAVE THE AUTHORITY TO EXECUTE THIS CONTRACT AND THAT I/WE INTEND THAT IT BE FULLY BINDING UPON ME/US PERSONALLY. I/WE ALSO ACKNOWLEDGE THAT IF THERE ARE ANY OTHER PERSONS OF WHICH I/WE AM/ARE AWARE THAT MUST EXECUTE THIS CONTRACT OR WHOSE SIGNATURE IS REQUIRED IN CONNECTION WITH THE DECISION TO PLACE MY/OUR CHILD AT THE SCHOOL, I/WE WILL IMMEDIATELY INFORM THE SCHOOL OF THAT INFORMATION. DO NOT SIGN OR SUBMIT UNTIL YOU HAVE READ THE ABOVE ACKNOWLEDGEMENT AND AGREEMENT.** The individual(s) signing the contract
