Local Planning.

Documents sent to BDC relating to the recent planning applications 15/00762/FUL; 15/00765/FUL; 15/00726/FUL; 15/00867/FUL and 15/00800/FUL as considered at the July meeting. The planning application re Colemans Farm Quarry: any decision has been deferred by ECC pending a site visit by all the members of the ECC D & R Committee.

ECC & SBC Joint Replacement Waste Local Plan.

In line with the Chairman's circulated comments, a the Council's response will be forwarded to ECC before the closure of the consultation period.

Rivenhall Airfield - Waste Incinerator Site.

ECC Roads Maintenance.

The speed loop requested for Rickstones Road has to be the subject of a LHP submission and this is being attended to.

The Chairman has requested the reinstatement of the "SLOW" roadway marking at Stoverns Hill, Rickstones Road.

The sunken roadside drain o/s 12 St. Mary's Road and the broken footway o/s number 24 have both been reported to ECC.

Notice of proposed carriageway repairs and road closure along Little Braxted Lane, commencing 10 August 2015.

Network Rail.

A site meeting, between the Chairman, Clerk and representatives from Network Rail, re the parking of network Rail vehicles near the Oak Road Railway Bridge when work is being undertaken in the area – took place on Monday 27 July 2015. Network Rail verbally agreed a plan of action to improve the space next to Footpath 47 - full details will be produced in due course. Network Rail also agreed to clear the roadside vegetation which has begun to encroach out from the bridge thereby reducing driver visibility.

Highways England - A12.

Notice received of the resurfacing work necessitating road closures to the A12 at Rivenhall End, due to commence on 27 July 2015 between 21.00 and 06.00 hours.

Braintree District Local Highways Liaison Panel.

The very latest information remains as follows:

- a. 7.5T weight restriction, Oak Road Fully approved at £46k less the £5k from RPC. There will be a public consultation period
- b. Extended 30mph limit along Church Road Scheme agreed for an additional 160 metres. There will be a public consultation period.
- c. Church Road/Oak Road highway signage Fully approved £8.5k; some cutting back of Church Road hedge will be required to improve visibility.
- d. Grass verge outside 51-53 Oak Road Scheme agreed.
- e. Rectory Lane traffic restrictions submitted for approval.
- f. Reflector bollards outside waterfall Cottages, Park Road submitted for approval.
- g. Introduction of a speed monitoring loop on Rickstones Road, at the bottom of Stoverns Hill submitted for approval.
